


SIGNATURE OMISSIONS

EASEMENT HOLDERS

THE SIGNATURES OF THE FOLLOWING EASEMENT HOLDERS HAVE BEEN OMITTED PURSUANT TO SECTION 66445 (e) OF PARCEL MAP OF THE GOVERNMENT CODE (CALIFORNIA SUBDIVISION MAP ACT):

- 1. A 20 FOOT WIDE AND 30 FOOT WIDE EASEMENTS FOR PRIVATE ROAD PURPOSES AS GRANTED TO SECURITY FIRST NATIONAL BANK OF LOS ANGELES IN DOCUMENT RECORDED NOVEMBER 28, 1930 IN BOOK 224, PAGE 276 OF OFFICIAL RECORDS.
- 2. 



VICINITY MAP
