Recommended Actions:

Consider recommendations regarding the Recruitment Process for filling a vacancy on the Retirement Board of the Santa Barbara County Employees Retirement System, as follows:

- a) Receive and file an update on the existing vacancy on the Retirement Board of the Santa Barbara County Employees Retirement System; and
- b) Consider the recommendation of the Board of Supervisors' subcommittee to appoint Jonathan Ziegler to the Retirement Board of the Santa Barbara County Employees Retirement System to complete the unexpired term of R. Guy Kraines ending December 31, 2014 and to fill a new three year term ending December 31, 2017.

Summary Text:

As of December 12, 2013, the Retirement Board of the Santa Barbara County Employees Retirement System has a vacancy due to the resignation of Board Member R. Guy Kraines. In response to direction from the Board, staff conducted a recruitment effort that included advertising the vacancy over several months in multiple editions of newspapers of general circulation countywide. The individual Board Offices also assisted in the outreach effort.

On September 9, 2014 the Board appointed a subcommittee consisting of Supervisor Peter Adam and Supervisor Janet Wolf and directed the subcommittee to interview potential candidates and return to the Board with a recommendation for appointment to complete the unexpired term of Mr. Kraines and to fill a new three year term ending December 31, 2017 (Retirement Board Seat #9).

On October 9, 2014 the subcommittee interviewed three of the four applicants, Trent Benedetti, Paul Coyne and Jonathan Ziegler. The fourth applicant, David Novis, asked that his application be withdrawn. After considering the qualifications of the applicants, the Board subcommittee is recommending that the Board appoint Jonathan Ziegler to the Retirement Board of the Santa Barbara County Employees Retirement System.

Attached (Attachment A) are the applications of the three individuals who were interviewed by the Board subcommittee, Trent Benedetti, Paul Coyne and Jonathan Ziegler.

Background:

The Retirement Board is composed of nine members and two alternates. One member shall be the County Treasurer. Four members are appointed by the Board of Supervisors and shall be qualified electors of the County, one of which may be a member of the Board of Supervisors. One regular member and one alternate are elected by retired members of the system, one regular and one alternate are elected by safety members of the system and two regular members are elected by the general members of the system. The appointments are for three year terms.
