That the Board of Supervisors:

Review and approve the Statement of Final Quantities for work performed and materials supplied for this project by the Contractor, AIS Construction Company (A Local Vendor), Post Office Box 239, Carpinteria, California 93014, in the amount of \$303,506.25.

Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No. 1, An Efficient Government Able to Anticipate and Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

On December 23, 2002, a large rock and boulder landslide occurred on Stagecoach Road at approximately one third-mile from Highway 154. The landslide forced the closure of the road for public safety reasons. Emergency measures were taken, and under a sole-source contract approved by the Board on January 21, 2003, the road remained closed while AIS Construction placed a cable mesh drapery cover over the slide area.

After late winter rains, an additional landslide was triggered on this slope, in areas adjacent to the original slide. Cracks were also developing in the formations, which indicated potential additional sliding in the near future.

Approval of a Change Order to the contract provided funds for an 84' x 184' extension of the cable mesh drapery covering this new slide area. This was done on an emergency basis so that the road could be safely opened and to minimize the inconvenience to the traveling public.

The project was completed on time and on budget.
