SUBJECT: Monument Deposit – Tract No. 14,483 Harris Grade Residential
Fourth Supervisorial District

Recommendation(s):

That the Board of Supervisors: Require the subdivider to post a certified check, bond or bank letter of credit of form to be approved by County Counsel in the amount of \$7,000.00 to guarantee interior monumentation of Tract No. 14,483 pursuant to Section 66496 of the State Subdivision Map Act.

The recommendation(s) are primarily aligned with Goal No. 1. An Efficient Government Able to Anticipate and Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

The Surveyor of Tract No. 14,483, located in an unincorporated portion of Santa Barbara County at the northeast corner of State Highway 1, Harris Grade Road and Purisima Road, Mission Hills area, Fourth Supervisorial District, has informed the County Surveyor's Office that he will be unable to have all of the property monuments in place at the time the map is recorded. The monuments are to be installed to meet the requirements of Section 66496 of the State Subdivision Map Act and Section 21-16 of the County Code Chapter 21 Subdivision Regulations. The County Surveyor recommends that the subdivider be required to provide surety in the form of a certified check, bond or bank letter of credit of form to be approved by County Counsel to guarantee installation of monuments.
