- b) Find that the Arbitrator abused his discretion when he erroneously interpreted and applied County's Mobile Home Rent Control Ordinance (§11A-5) contrary to its plain meaning and in a manner not permitted by law concerning the automatically allowable rent increase; and
- c) Remand Issue #8 to the Arbitrator with directions to calculate the automatically allowable rent increase in the manner required by law by using the percent increase over the 12 months immediately preceding January 2004 (i.e. 2.0%), instead of the averaged annual 12 month percent increase for 2003 (i.e. 3.0%), consistent with the plain meaning of Ordinance section 11A-5(a) and applicable data available from the U.S. Department of Labor;

change in governmental law or regulation".

e) Remand Issue #9 to the Arbitrator with the directions to cite, on the basis of the record of the hearings held on July 26 and July 30, 2004 before the Arbitrator, the substantial evidence, if any, which supports his determination that the Park may pass through the cost of replacing the water, gas, and electrical meters.
