WHEREAS, Susan L. Warnstrom has been chosen Woman of the Year by the Lompoc Valley Chamber of Commerce for the year 2007; and

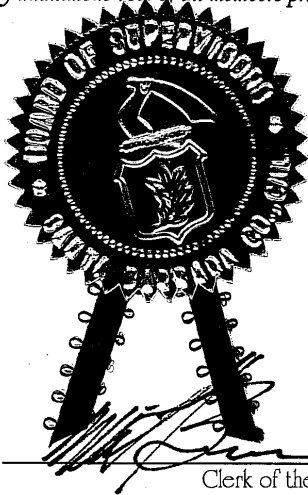
