Transfer appropriations for Public Defender DSH SHIELD Staffing

Budget Action: Increase appropriations of \$103,500 in General County Programs General Fund for Intrafund Expenditure Transfers (+) funded by release of Committed AB 199 Fund Balance. Increase appropriations of \$103,500 in the Public Defender's Office General Fund for Salaries and Benefits funded by an Intrafund Expenditure transfer from the General County Program General Fund.

Justification:

The Department of State Hospitals (DSH) approved the County's FY 2022-23 Growth Cap Expenditure Plan, returning \$414,000 in penalty funds to implement the SHIELD diversion program, which is being held in the General County Programs General Fund Committed AB 199 fund balance. This budget revision appropriates \$103,500 in FY 2025-26 to fund 1.0 FTE Holistic Defense Advocate in the Public Defender's Office, providing early intervention and treatment linkage to reduce felony Incompetent to Stand Trial (IST) determinations. Year two and year three costs will incare ase annually by 5% plus cost-of-living adjustments (COLA), with savings from year one funding the increased costs in years two and three. Expenditures are restricted to the approved plan and subject to DSH reporting requirements.
