### **Recommended Actions:**

That the Board of Supervisors:

- a) Approve and authorize the Chair to execute a Thirteenth Amendment to Agreement for Services with Aramark Corporation (Aramark Correctional Services, LLC) for jail food services to extend the term on a month-to-month basis not to exceed 155-Days and expiring on September 30, 2021, in an amount not to exceed \$550,000; and
- b) Determine that the above actions are government fiscal activities or funding mechanisms which do not involve any commitment to any specific project which may result in a potentially significant impact on the environment, and are therefore not a project under the California Environmental Quality Act (CEQA) pursuant to section 15378(b)(4) of the CEQA guidelines.

<u>Summary Text:</u> Aramark Corporation currently provides all the necessary food supplies, kitchen services and program support for the provision of food to inmates and staff in support of the daily operation of the Santa Barbara County Main Jail. On January 14, 2020, the County of Santa Barbara released a request for proposal for correctional kitchen services for both the Main Jail and the Northern Branch Jail (NBJ). Due to fluctuating opening date of the NBJ, this thirteenth amendment allows for the Sheriff's Office to provide kitchen services in the Main Jail until a new agreement is attained for kitchen services.

### Background:

On July 10, 2012, the Sheriff's Office entered into a contract (Attachment C) with Aramark Corporation to provide kitchen services for the Sheriff's Office Main Jail. The Sheriff's Office, Custody Division, Jail Administration and Sheriff's Food Supervisor have provided oversight jail food services contract for the past eight years. Aramark has provided all the necessary food supplies, kitchen services and program support for provision of food to inmates and staff in support of the daily operation of the Santa Barbara County Jail in conjunction with the Sheriff's Food Supervisor. This contract was awarded to help support the jail kitchen sewer remodel project.

This is the sixth request for an extension and thirteenth amendment. Amendments 1 through 6 and 9 (Attachment F) were due to CPI calculations pursuant to Section 20 of the original Agreement. Amendments 7, 8, 10, 11 and 12 (Attachment B) were the first, second, third, fourth, and fifth requests for extension respectively. The extension period is on a month-to-month basis, in anticipation of a new kitchen services agreement and aligning this contract with the fluctuating opening date of the Northern Branch Jail. Due to COVID-19, we are still in the negotiation process and will be coming back to the Board within the next few months with a new agreement.
