WHEREAS, Notices of Cessation of Work for public improvement projects may be signed and verified by the Owner or its designated agent pursuant to Civil Code Section 3092 until July 1, 2012, and pursuant to Civil Code Section 9202 on and after July 1, 2012; and

WHEREAS, the Board Chair presently signs these Notices, and designating an appropriate agent instead would eliminate the need to agendize these routine Notices, thus allowing the Board to address more pressing matters; and

WHEREAS, the Public Works, General Services, and Parks Departments' efficiency would also improve, allowing staff to file the Notices of Completion or Notices of Cessation of Work in a timely manner and achieve Civil Code timelines;

NOW, THEREFORE, IT IS HEREBY RESOLVED, that this Board authorizes the Directors of Public Works, General Services and Parks each to act as "agent" on behalf of the County, Laguna County Sanitation District and Santa Barbara County Flood Control and Water Conservation District, to sign and verify Notices of Completion and Notices of Cessation of Work for public improvement projects; and

BE IT FURTHER RESOLVED, the Directors of Public Works, General Services, and Parks, acting as "agent" for the County, shall each have the authority to present the fully executed Notices
