# Recommended Action(s):

That the Board of Supervisors approve and authorize the Chair to sign the attached letter and application to the Department of Alcohol Beverage Control (ABC) determining that public convenience will be served by approving the new Off-sale Beer and Wine license to Ana Maria Mederosmedina and Jose Flores Zepeda, located at 1410 Burton Mesa Blvd., Lompoc.

## **Summary:**

On June 2, 2006, Ana Maria Mederosmedina and Jose Flores Zepeda applied for a Type 20 Off-Sale Beer and Wine license from the Department of Alcohol Beverage Control for a deli/convenience market at 1410 Burton Mesa Blvd in Lompoc. To meet the requirements of Business and Professions Code 23958 and 23958.4, the Board of Supervisors must act on a letter of Public Convenience and Necessity within 90 days of the applicant's request.

Based on staff's review of the applicant's request, the County Executive Office recommends that the Board issue a letter to the Department of Alcohol Beverage Control (ABC) finding that public convenience will be served by the approval of the issuance of the off-sale beverage license. As such, a letter and the form from the ABC have been prepared and are attached for the Board's consideration.

#### **Background:**

The number of licenses allowed for this census tract is four. Four licenses exist, thus triggering the need to determine whether public convenience would be served by approving the application for an off-sale beer and wine license.

The Planning and Development Department has stated that the location is zoned SC and is one of the few established and permitted shopping centers in the Mission Hills Area. This zone type allows the use of a deli/convenience market.
