**Summary Text:**

Each January, the Board of Supervisors reviews and considers appointments to Boards, Commissions, and Committees on which its members serve.

Attachment 1 provides the 2025 Board of Supervisors Appointments to Boards, Commissions, and Committees as approved at the January 7, 2025, Board meeting. Attachment 2 organizes these appointments by individual Supervisor.

In addition to the appointments listed in Attachment 1, all members of the Board of Supervisors serve on the Board of Directors for the Santa Barbara County Association of Governments (SBCAG) and the Santa Barbara County Air Pollution Control District (APCD). Board members also participate in Ad-Hoc Sub-Committees as determined by the Board.

The list of Boards, Commissions, and Committees in Attachment 1 will serve as a guide for making the 2026 Board of Supervisors appointments at the January 13, 2026, Board meeting. This year's list is the same as the 2025 list except the Central Coast Area Agency on Aging (AAA) has been excluded. The State of California Health and Human Service Agency on December 16, 2025 issued a notice of intent to revoke the Central Coast AAA designation due to noncompliance. Staff will return to the Board at a later date for further action as necessary.

**Background:**

The Board of Supervisors serve on various Boards, Commissions, and Committees as representatives of the County. These appointments involve active participation in meetings and decision-making processes on critical regional and statewide matters, including transportation, air quality, water management, housing, and public health. Through these roles, Supervisors ensure that the County's interests are effectively represented and contribute to shaping policies that address the needs of the county.

Board of Supervisor appointments to Boards, Commissions and Committees are mandated by County Ordinances, Resolutions or Minute Orders and, as appropriate, State Statute.
