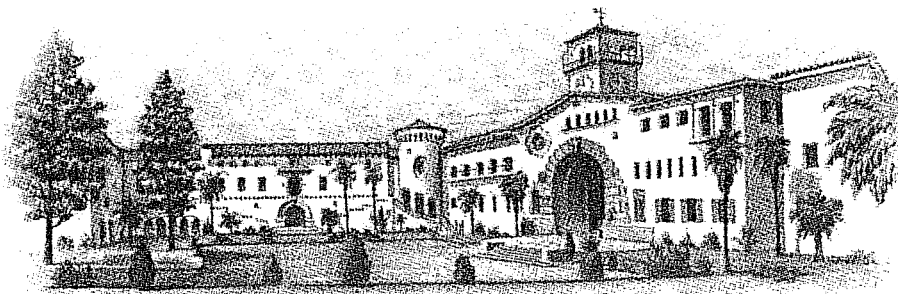


To Clerk, Board of Supervisors:

It was this interest that brought me to Cal Poly, San Luis Obispo, where I earned my Bachelor's of Landscape Architecture. I pursued my interests in horticulture by studying habitat restoration and California native plants. My interest in native plants led me to my thesis to rejuvenate the Santa Barbara Botanic Garden. In the past six years I have become familiar with the architectural review process through the design and implementation of landscape plans submitted to the various departments, boards, and committees of the county and city of Santa Barbara.
