- A. Approve and execute Contract Change Order Number 1 in the amount of \$13,328.60 for Construction of Concrete Sidewalk and Curb Ramps at Various Locations in Isla Vista, Project No. 310300
- B. Re-establish the project contingency fund in the amount of \$8,378.10 for Construction of Concrete Sidewalk and Curb Ramps at Various Locations in Isla Vista, Project No. 310300 (Phase 3).

Executive Summary and Discussion:

Your Board entered into a contract on July 15, 2003, in the amount of \$92,159.10, including contingency, with Lash Construction Company (A Local Vendor) for the Construction of Concrete Sidewalk and Curb Ramps at Various Locations in Isla Vista.

Construction of Concrete Sidewalks and Curb Ramps in Isla Vista

Contract Change Order No. 1, in the amount of \$13, 328.60 is for the construction of additional sidewalks and a curb ramp located at 6595 Cordoba Road. This project will construct missing segments of sidewalks in Isla Vista. These facilities are necessary to create continuous pedestrian facilities and access.

The original contingency fund for this project was \$8,378.10. Approval of Contract Change Order (CCO) No. 1 will exhaust the contract contingency amount by \$4,950.50. At this time Public Works is requesting that the contingency fund be restored to its original amount of \$8,378.10.

Per the Public Contract code, section 20137, change orders more than 10% of the original contract amount requires a four-fifths vote by the governing body. With the approval of CCO Number 1, the total contract amount will be \$105,487.70. Your Board approved this sidewalk improvement project in the FY 01/02 Capital Improvement Plan.
