### WHAT IS THE ROADWAY ENHANCEMENT PARTNERSHIP PROGRAM?

#### Roadway Enhancement Partnership Program (REPP)

- Volunteers donate their time, material, and funding for improvements on the County road right-of-way.
- Modeled after "Adopt a Highway" programs around the Country

#### **Public Works selects projects that:**

- Improve safety
- Enhance beauty
- Promote a cleaner environment for the traveling public.





#### REPP HISTORY

- REPP was created to augment the Partnership Program\*
  - \* A cost-sharing agreement between homeowners and the County to fund hardscape repairs.
- The Board of Supervisors approved REPP on September 20, 2005.



- We face a constant challenge to balance funding shortfalls and maintenance backlog.
- These are two innovative programs Public Works created to help meet that challenge.



### REPP PROJECTS



#### **REPP Projects include:**

- Tree planting and maintenance
- Litter pick-up and debris removal
- Graffiti removal
- Drainage repairs
- Landscaping projects
- Street sweeping
- Roadway surface treatments
