My name is Lollie Katz. I am a senior citizen and a first responder working in a local nursing facility as a nurse practitioner. I was very happy when the mask ordinance went into effect and wondered when I heard the health officer make a statement heard on the local public radio station that there is evidence for and against the use of face coverings. I wondered if this was an implicit message that the order would be rescinded sooner rather than later.

I have been compliant with the stay at home order and was an early advocate of this mitigation plan including the use of masks aka facial coverings. I didn't understand why the CDC and other health experts advised the public against their use and felt it was misleading and disingenuous. I have sewn nearly 200 face coverings that have been donated to family, friends, health centers here and out of state.

I work in a local nursing facility and know that relaxation of the ordinance will increase the likelihood of exposing my very elderly and vulnerable patients to Covid, cause a financial hardship if I am forced to suspend my work and last but not least, increasing the likelihood, personally, of succumbing to a serious if not life threatening illness.

Please, please keep this order in place.
