SUBJECT: Cachuma Resource Conservation District Board Appointments in Lieu of Election

Recommendation(s):

That the Board of Supervisors:

Set a hearing for November 15, 2005 to consider the appointment of the four most qualified candidates to the Cachuma Resource Conservation District Board of Directors no later than December 1, 2005.

Alignment with Board Strategic Plan:

The recommendation is primarily aligned with actions required by law or routine business necessity.

Executive Summary and Discussion:

In 1986, Section 9314 of the Public Resources Code was amended to allow Resource Conservation Districts to request that the Board of Supervisors appoint directors to the governing board of their district.

At the June 21, 2005 meeting, the County Board of Supervisors approved a resolution from the Cachuma Resource Conservation District requesting that your Board appoint its directors as provided for in Public Resources Code Section 9314.

On August 12, 2005, the close of the candidate filing period, the number of candidates filing a Declaration of Candidacy for the Cachuma Resource Conservation Board exceeded the number of positions to be filled. Five candidates filed Declarations of Candidacy with the Santa Barbara County Elections Offices to fill the four expiring terms. Copies of each Declaration have been included for your consideration (*see Attachment A*). Each of the following candidates has met all qualifications for appointment to the Cachuma Resource Conservation District Board of Directors:
