That the Board of Supervisors:

- a) Approve, ratify, and authorize the Chair of the Board of Supervisors to execute the First Amendment to the Professional Services Agreement (Board Contract No. 20198) with The Gordian Group, Inc., a Georgia corporation doing business in California as The Mellon Group (Gordian) provided as Attachment A, increasing the maximum compensation limit from \$1,000,000.00 to \$1,250,000.00 and extending the Term until November 30, 2025; and
- b) Determine that the recommended actions are not a project subject to environmental review under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15378(b)(4) as the actions are the creation of government funding mechanisms or other government fiscal activities which do not involve any commitment to any specific project; and Section 15378(b)(5), as the actions are the organizational or administrative activities of governments that will not result in direct or indirect physical changes in the environment

Summary Text:

This action authorizes the Chair to execute the First Amendment (Amendment) to Board Contract No. 20198 with Gordian to increase the maximum compensation limit from \$1,000,000.00 to \$1,250,000.00, and extend the Term until November 30, 2025. The Amendment provides for the continued development, implementation, and management of the County's Job Order Contracting (JOC).

Background:

In 2020, the State Legislature expanded authority for counties to utilize Job Order Contracting (JOC) as an alternative project delivery method under the California Public Contract Code. JOC is designed to streamline procurement and delivery of repair, remodeling, and other repetitive work by using pre-priced unit tasks and competitively bid adjustment factors, allowing the County to respond quickly to facilities needs while ensuring transparency and cost control.

On October 1, 2022, the Board approved Contract No. 20198 with Gordian, a nationally recognized JOC program manager, to provide development, implementation, and ongoing support of the County's JOC program. The original agreement authorized a three-year term with two optional one-year extensions, not to exceed \$1,000,000.00 in total compensation. Since then, Gordian has assisted the County in building program infrastructure, including catalog development, contract compliance oversight, and training for internal staff and contractors.

The JOC program has been very successful and therefore the volume of projects initiated under the program has increased, resulting in a higher level of technical and administrative support required from Gordian. The proposed Amendment extends the contract term briefly to November 30, 2025, and adjusts the maximum contract value to \$1,250,000.00 to ensure uninterrupted continuation of services.

This action maintains compliance with legislative authority under the Public Contract Code and aligns with prior Board direction to expand the County's use of alternative project delivery methods to improve efficiency in capital project delivery.

Fiscal and Facilities Impacts:

Budgeted: Yes

The JOC program is funded through the budget allocations of individual projects. When an individual project uses the JOC program, the project will also fund Gordian's fees. Gordian charges a 5% License and Job Order Development Fee when a job order is issued to a JOC contractor. The amended maximum amount for Gordian's services during this contract period will be up to and not to exceed \$1,250,000.00. Funds for these services are included in the approved budget allocations and accounted for as part of each individual project ordered utilizing the JOC method.
