RESOLUTION NO. 20-131

WHEREAS, a report pursuant to Health and Safety Code Section 5473 was filed with the Clerk of the Board; and

WHEREAS, notice of said hearing has been published pursuant to Government Code Section 6066; and

WHEREAS, it appears to be in the best interest of the public and to the inhabitants of said District that service charges and connection charges within said District be collected on the County Tax Roll; and

WHEREAS, the service charges and connection charges appear to be reasonable and proper.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED as follows:

1. That the foregoing recitations are true and correct.
2. That the service charges and connection charges fixed by Ordinance No. _____ and set out in said report, and each of them, be collected at the same time and in the same manner and by the same persons as, together with and not separate from the general taxes, for the Laguna County Sanitation District.
3. The Clerk of the Board is directed to file with the County Auditor-Controller, on or before August 10, 2020, a certified copy of this Resolution and the report, indicating adoption by the Board in accordance with Health and Safety Code Section 5473.4. Upon such filing, the County Auditor-Controller shall enter the charges on the tax roll for the 2020-2021 fiscal year. The charges shall be collected at the same time and in the same manner, and subject to the same penalties and priority of

lien as, County taxes are collected, and all laws providing for the collection and enforcement of County taxes shall apply to the collection and enforcement of the charges.




