

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE

WHEREAS, the Transportation Development Act (TDA), as amended (Public Utilities Code Section 99200 et seq.), provides for the allocation of funds from the Local Transportation Fund and the State Transit Assistance Fund, for use by eligible claimants for various transportation purposes;

WHEREAS, pursuant to the provisions of the TDA, as amended, and pursuant to the applicable rules and regulations thereunder (21 CCR §§ 6600 et seq.) a prospective claimant wishing to receive an allocation from the Local Transportation fund or the State Transit Assistance Fund shall file its claim with the Santa Barbara County Association of Governments;

NOW, THEREFORE, BE IT RESOLVED, that the County Public Works Director is authorized to execute and file an appropriate claim and necessary claim amendments pursuant to applicable rules and regulations promulgated hereunder, together with all necessary supporting documents, with the Santa Barbara County Association of Governments (SBCAG) for an allocation of TDA funds in FY 2025-2026;

BE IT FURTHER RESOLVED THAT the authorized claim includes \$107,270 for SBCAG's regional transportation planning, \$155,439 for pedestrian and bicycle facilities, \$152,279 for streets and roads, \$150,000 for transit, and allocates \$3,073,000 for Santa Maria, Lompoc, Solvang, Guadalupe, SMOOTH, SBCAG, and Easy Lift; a total claim amount of \$457,718 from the \$3,637,988 TDA-Local Transportation Fund (TDA-LTF) allocation for FY 2025-2026; and

BE IT FURTHER RESOLVED THAT a copy of this resolution be transmitted to the Santa Barbara County Association of Governments in conjunction with the filing of the claim.
