Justification: The purpose of this budget revision request is to establish appropriations for the installation of new safety lighting on the Obern bike and pedestrian trail. The Obern Trail

represents the South Coast's highest volume cycling commuter corridor accommodating thousands of bicycling commuters and students each day. Currently, the path is illuminated with severely deteriorated high-pressure sodium pathway lights installed over 30 years ago and are inefficient and require frequent maintenance. The addition

of reliable safety lighting dramatically enhances the safety for commuters using the facility.

This funding for this project will be used \$446K for construction that is going to bid with the associated Board Letter and \$54K for construction engineering to be done by PW Roads staff. This projects will be funded by a combination of SBCAG Measure A Grant (170K), operating transfers from Fund 0019 PW Roads Alternative Transportation fund balance (\$120K) and Fund 2120 -CSA 3 Unicorp Goleta Valley fund balance (110K), and Fund 0018 PW Roads - Measure A South
