

Budget Action:	Increase appropriations of \$250,000 in Community Services General Fund for Services and Supplies (100,000) and Capital Equipment (\$150,000), funded by an Intrafund Expenditure Transfer (-) from General County Programs. Increase appropriations of \$250,000 in General County Programs General Fund for Intrafund Expenditure Transfers (+) funded by release of Committed Emerging Issues fund balance.
Justification:	On June 16, 2023, the Board set aside \$500,000 in one-time funding in the General County Programs General Fund Committed Emerging Issues fund balance to develop or pilot programs and projects that might be pursued once the Final Climate Action Plan were to be adopted. Funds have been held in abeyance pending Board consideration and approval of specific projects or programs. On August 27, 2024, the Board adopted the 2030 Climate Action Plan.
	Through this budget revision request staff is seeking authorization from the Board to allocate \$250,000 from the Sustainability Initiatives funding held in General County Programs for the recommended projects. The projects will help to initiate progress toward completing several actions from the recently adopted 2030 Climate Action Plan.
