WHEREAS, the issue of hunger and food insecurity continues to impact communities across the U.S., including right here in Santa Barbara County; and

WHEREAS, access to sufficient and nutritious food is a fundamental human right, and efforts to eradicate food insecurity require collaborative action from individuals, organizations, and government entities; and

WHEREAS, Hunger Action Month, observed annually in September, serves as a reminder of the urgent need to raise awareness about food insecurity and mobilize efforts to address it;

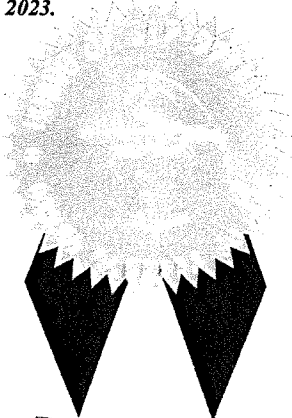
