SUBJECT: Personnel Actions in the Department of Social Services

Recommendation(s):

That the Board of Supervisors: adopt one (1) resolution, effective January 19, 2004 to consolidate seven classes into three, as follows:

ESTABLISH JOB CLASSIFICATIONS

Career Employment Specialist, (Class 001416), Range 4796 (\$2,653-\$3,239 per month); Career Employment Specialist, Senior (Class 001417), Range 5036 (\$2,990-\$3,651 per month); Career Employment Specialist Supervisor (Class 001418), Range 5336 (\$3,473-\$4,240 per month).

DELETE JOB CLASSIFICATIONS

Career Employment Specialist I, (Class 001411), Range 4774 (\$2,624-\$3,203 per month); Career Employment Specialist II, (Class 001412), Range 4904 (\$2,800-\$3,418 per month); Career Employment Specialist III, (Class 001413), Range 5024 (\$2,972-\$3,629 per month); Career Employment Specialist, Supervising (Class 001414), Range 5324 (\$3,452-\$4,214 per month); Job Training Specialist Counselor I, (Class 003110), Range 4796 (\$2,653-\$3,239 per month); Job Training Specialist Counselor II, (Class 003111), Range 5036 (\$2,990-\$3,651 per month); Job Training Specialist, Supervisor, (Class 003107), Range 5556 (\$3,876-\$4,731 per month).

Reclassify: 9 (9.0 FTE) Job Training Specialist Counselor I/II (Classes 003110/003111) to Career Employment Specialist/Specialist, Senior (Classes 001416/001417).

Reclassify: 12 (12.0 FTE) Career Employment Specialist Supervising (Class 001414) to Career Employment Specialist Supervisor (Class 001418).

Reclassify: 2 (2.0 FTE) Job Training Services Supervisor (Class 003107) to Career Employment Specialist Supervisor (Class 001418).

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 3. A Strong, Professionally Managed County Organization.

Executive Summary and Discussion:

Proposed new classifications:

The proposed new classifications represent a consolidation/collapsing of the Career Employment Specialist I/II/III and Job Training Specialist I/II class series into a new "Career Employment Specialist" series. While we are recommending establishing 3 new classifications, if approved, the following 7 classifications would be deleted, effectively reducing the overall number of classifications in the Social Services Department by 4:

Career Employment Specialist I
Career Employment Specialist II
Career Employment Specialist III
Career Employment Specialist, Supervising
Job Training Specialist Counselor I
Job Training Specialist Counselor II
Job Training Specialist Supervisor

Department Requesting the New Classifications: Social Services Department

Background: The transfer of the Job Training Network to Social Services brought three new classifications into the department, Job Training Specialist I and II and Job Training Specialist, Supervisor, all of which are essentially duplicative of the department's Career Employment Specialist class series used in the CalWORKS program. Social Services requested that Human Resources study the feasibility of merging the two class series, inasmuch as Social Services believed the functions of each series to be substantially similar and because it was also appropriate to assess the CES series now that CalWORKs had been completely implemented.

Service Level/Organizational Impact: The collapse of the CES and JTS classes into a single classification series will improve the department's ability to adapt to future changes in the CalWORKS and WIA programs. There are no negative impacts on service levels. Other Social Services programs, County departments, and the County organization as a whole will not be impacted by this change.

Class concept: The proposed flex classifications will be assigned to one or more of the employment services programs within Social Services, and are responsible for providing direct client services in the areas of

employment counseling, needs assessment, vocational evaluation, employment preparation, referral to support services, etc. The proposed supervisor classification is responsible for supervising the work of staff providing these client services.

Compensation Factors: The salary recommendations were based on internal relationships within the Social Services Department.

Fiscal Impact: The annual fiscal impact of this request is approximately \$59,000. The increase will occur in CalWORKs and will be covered by unanticipated TANF incentive funds for the next 3-4 years; thereafter it will be covered by salary savings or new revenue. Since CalWORKs has a fixed maintenance of effort there is no impact on the General Fund.

Freeze Exemption: Your Board implemented a temporary freeze on reclassifications effective December 10, 2003. However, the County began meeting and conferring in October with affected employee organizations regarding the recommended reclassification, and representatives of the County and SEIU Local 620 and 535 reached overall agreement on December 11 regarding the impacts of the proposed action. In light of these ongoing efforts and in the interest of bringing this process to a successful conclusion, the County Administrator and Human Resources staff recommend that this reclassification action be implemented as an exception to the temporary freeze.
