Recommended Actions:

That the Board of Supervisors approve and execute the attached Amendment No. 1 to the Agreement for Professional Legal Services with outside tax counsel, Ice Miller LLP, a law firm in Indianapolis, Indiana. The amended Agreement is for an amount not to exceed \$131,000.

Summary Text:

On March 6, 2007, the Board approved an Agreement for Professional Services with Ice Miller covering their review of documentation related to the Santa Barbara County Employees Retirement System (SBCERS) and a two-day due diligence session. The Agreement stated that following the due diligence session, Ice Miller would work with County staff to identify the specific goals and objectives of Ice Miller's engagement and to create a more detailed scope of work with cost estimates.

This Amendment No. 1 amends the Scope of Work to include review of the SBCERS plan document for compliance with the Internal Revenue Code, GASB 45, and IRS requirements. The amended Agreement covers Ice Miller's presentation of a summary of federal law governing funding options and benefit structures for future retiree healthcare, the preparation of necessary documents, and the submission of them to the IRS for approval if requested by County. It also covers Ice Miller's presentation of alternatives for replacement plans for administrators and subsequent legal services related to such plans. The amended Agreement also includes other related legal services as described in the Scope of Work. For example, it includes Ice Miller's review of the County's continuing disclosure filing for the County's
