This is the first Amendment to the Agreement between THE COUNTY OF SANTA BARBARA (hereinafter "County") and Rincon Consultants, Inc. (hereinafter "Contractor").

WHEREAS, on July 16, 2019, the parties hereto entered into an **Agreement for Services of Independent Contractor BC19645 (hereinafter "Agreement")** for environmental analysis and field assessment activities at 3900 Paradise Road associated with the Los Prietos Boys Camp ("Project"); and

WHEREAS, the Agreement was initially for 6 months; and

WHEREAS, the parties hereto desire to amend the Agreement ("Amendment No. 1"), in accordance with the provisions of the Agreement, to extend the term.

NOW, THEREFORE, Owner and Contractor agree as follows:

1. Amendment No. 1 increases the term of the contract and replaces the "PERFORMANCE PERIOD" clause with the following:

CONTRACTOR shall commence performance on July 22, 2019 and end performance on completion, but no later than January 22, 2021 unless otherwise directed by COUNTY or unless earlier terminated.

2. Except as otherwise amended by this Amendment, all of the terms and conditions of the Agreement shall remain in full force and effect.
3. The signatories to this Amendment have the authority to bind the parties. This Amendment may be executed in counterparts, each of which shall be deemed to be an original, and all of such counterparts shall together constitute one executed original instrument.


