

**FIFTH AMENDMENT TO MEDI-CAL PHYSICIAN SERVICES PROVIDER AGREEMENT,
FEDERALLY QUALIFIED HEALTH CENTER**

This Fifth Amendment to the Medi-Cal Physician Services Provider Agreement, Federally Qualified Health Center ("Fifth Amendment") is made between the **Santa Barbara San Luis Obispo Regional Health Authority**, dba CenCal Health, a body corporate and politic, hereinafter referred to as "CenCal Health", and the **County of Santa Barbara**, an organization approved by the State Department of Health Care Services as a Federally Qualified Health Center (hereinafter referred to as "County"). (County and CenCal Health are jointly "the parties").

RECITALS

- A. CenCal Health and County entered into the Medi-Cal Physician Services Provider Agreement, Federally Qualified Health Center ("Agreement") effective January 1, 2012 through December 31, 2017.
- B. CenCal Health and County now desire to extend the ACE Program and ACE Incentive Payment for Expansion Members in exchange for continuation of Enhanced Services through December 31, 2015.
- C. This Fifth Amendment incorporates the terms and conditions set forth in the Agreement and all Amendments approved by the County of Santa Barbara and CenCal Health.

NOW, THEREFORE, the parties agree as follows:

- 1. The above Recitals are true and correct.
- 2. This Amendment shall be effective on July 1, 2015 through December 31, 2015.
- 3. Exhibit A - ACE – County of Santa Barbara ACE Incentive Payment For Expansion Members, dated January 1, 2015, is deleted in its entirety and is replaced by Exhibit A - ACE – County of Santa Barbara ACE Incentive Payment For Expansion Members, dated July 1, 2015, attached and incorporated by reference herein.
- 4. Except as amended by this Fifth Amendment, the Agreement will remain in full force and effect.

COUNTY OF SANTA BARBARA ACE INCENTIVE PAYMENT FOR EXPANSION MEMBERS

1. Current and Anticipated Rates for Expansion Members

July 1 – Dec 31, 2015

Rate: \$12.75

2. Method and Timing of Payment

a. ACE Incentive Payment

A payment covering the six (6) months of the Term of this agreement shall be made by CenCal Health to County within ten (10) business days of the full execution of this Amendment. The amount paid will be made in a single aggregate payment, but will be calculated on a per month basis as follows:

Monthly Assigned Case Managed Expansion Membership x rate

b. Summary Report

County shall receive a Summary Report showing the calculation of the amount paid by CenCal Health to County to accompany the ACE Incentive Payment.
