WHEREAS, the County of Santa Barbara and the Santa Barbara Superior Courts share responsibility (including possession, occupancy, use, and operation) for real property known as the "Cook and Miller Campus" in Santa Maria, the terms of which, are summarized in a Transfer Agreement and a Joint Occupancy Agreement between the County of Santa Barbara and the Judicial Council of the California, Administrative Office of the Courts dated November 26, 2008; and

WHEREAS, the aforementioned Transfer Agreement and Joint Occupancy Agreement specifies that 11 parking spaces are reserved for judicial officers of the court and that the costs and expenses of the operation of the parking lot is the responsibility of the Administrative Office of the Courts; and

WHEREAS, Santa Barbara Superior Court has requested that the County of Santa of Barbara designate an additional 11 parking spaces for a total of 22 parking spaces for exclusive use by judicial officers and executive court staff; and

WHEREAS, Vehicle Code Section 21113(a) states that no person shall park on County property "...except with the permission of, and upon and subject to any condition or regulation which may be imposed by the legislative body of the municipality, or the governing board..."; and

WHEREAS, the Sheriff of Santa Barbara County may enforce this Resolution as appropriate and/or necessary;

NOW, THEREFORE, BE IT RESOLVED, that pursuant to Vehicle Code §22519 the Board of Supervisors of the County of Santa Barbara, State of California does hereby find, determine and order as follows:

- 1. The above recitals are true and correct.
- 2. That in accordance with Vehicle Code Section 22659, the Board of Supervisors of the County of Santa Barbara, California, designates the 22 parking spaces labeled "court" on the attached Exhibit "A" as parking for state judicial officers and executive court staff only, and no person other than state judicial officers or executive court staff of the Superior Court of California shall stop, stand or park any vehicle therein when such area is indicated by appropriate

signs. Any vehicle parked in violation of this resolution shall be subject to towing and removal to a storage facility.

This resolution shall remain in effect unless rescinded by the Board. PASSED AND ADOPTED by the Board of Supervisors of the County of Santa Barbara, State of California, this 10th day of May 2011, by the following vote:
