Title: CSD: Arroyo Burro Boardwalk Project

Budget Action: Establish Appropriations of \$528,000 in the Community Services Department, Parks Division, Capital Projects Fund for Capital Assets funded by unanticipated revenue

from Charges for Services (\$468K) and an operating transfer from the General Fund (\$60K). Transfer Appropriations of \$60,000 in the Community Services Department,

Parks Division, General Fund from Services and Supplies to Other Financing Uses for Arroyo Burro Boardwalk Project.

Justification: Arroyo Burro Beach Park is a popular County beach in Santa Barbara that is frequented by over 700,000 visitors on an annual basis. Aside from being a frequently used

beach (and dog beach), the beach park has a popular restaurant on site as well as a watershed resource center. A 6,750 sf. decomposed granite (dirt) pathway along the estuary currently exists at the park, and is the main path of travel from the easterly section of the parking lot and bus stop. The project costs would cover construction and management to install an eco-friendly, well-lit boardwalk in place of the existing decomposed granite pathway and provide an improved walking path for visitors, provide improved parking lot site drainage at three locations, adjust ADA parking stalls and install landscaping to deter egress off of the boardwalk. Sources of funding are Boathouse Utility Repayments (\$60,000), Fund 1405 Developer Mitigation Fees - South Coast West (\$179,000) and Fund 1400 Quimby Fees - South Coast West

(\$289,000). Unencumbered fund balances for Fund 1400 and Fund 1405 are approximately \$364K and \$439K, respectively.
