**Summary:**

This project was one of the strategies the Department employs in its annual Pavement Preservation Program and consists of the application of a slurry seal coat on the existing pavement surface at various locations throughout Santa Barbara County. Approximately 68 lane miles of county maintained roadway were resurfaced with the construction of this project.

The Director of Public Works accepted this project as complete on December 15, 2005. The project was completed on time and under the allotted contract amount.
