Recommended Actions:

That the Board of Supervisors:

- a) Approve, ratify, and authorize the County Fire Department Office of Emergency Management to accept \$446,265 in Fiscal Year 2024 Homeland Security Grant Program (HSGP) federal grant funds as distributed through the California Governor's Office of Emergency Services (Cal OES) with a period of performance from September 1, 2024 to May 31, 2027; and
- b) Adopt a resolution (Attachment A) to appoint the County Executive Officer (CEO), the Director of Office of Emergency Management (OEM), County Fire Chief, and Fire Department Chief Financial Officer (CFO) to act as Authorized Agents to apply and submit a grant application, execute all required grant application documents (including assurances and certifications), and take any actions necessary for each application and subaward under the Homeland Security Grant Program (HSGP) with Cal OES to provide grant funding on behalf of the Santa Barbara Operational Area for the grant Fiscal Year 2024. The resolution directs the Authorized Agents to, if applicable, make necessary budget revisions, and delegates authority to execute grant agreements with the State and execute subrecipient agreements with Operational Area subrecipients upon concurrence by the Auditor-Controller, Risk Management, and County Counsel; and
- c) Determine that the proposed actions are related to the creation of a government funding mechanism and other fiscal activities which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment, and is therefore exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guideline section 15378 (b)(4).

Summary Text:

This item is to approve the Fire Department Office of Emergency Management's acceptance of Homeland Security Grant Program (HSGP) funds, with a period of performance from September 1, 2024 to May 31, 2027. Additionally, the resolution (Attachment A) appoints the County Executive Officer (CEO), Director of Office of Emergency Management (OEM), County Fire Chief, and Fire Department Chief Financial Officer (CFO) to act as Authorized Agents to execute any actions necessary for HSGP applications and subawards under the HSGP.

By regulation and grant guidance, the Santa Barbara County HSGP Approval Authority is composed of the County Fire Chief, County Sheriff, Municipal Police Chief Representative, Municipal Fire Chief Representative, and County Public Health Department Director, and governs allocation of HSGP funds (collectively referred to as "Approval Authority"). While the Board is approving acceptance of the grant and delegating its management, it is the Approval Authority who identifies and approves the projects within each grant cycle. The Approval Authority meets quarterly throughout the year to receive and communicate status updates on grant projects and requirements.

Background:

The Santa Barbara County Operational Area consists of the County and all governmental subdivisions within the County, including the eight incorporated Cities, and numerous Special Districts. The Santa Barbara County Operational Area qualifies for a grant referred to as the Homeland Security Grant Program (HSGP). This federal grant has assisted the Operational Area in the purchase of a variety of vital equipment, trainings, plans and programs for emergency response agencies. Each year emergency response agencies propose projects to the Santa Barbara County HSGP Approval Authority. The OEM works with the HSGP Approval Authority to review projects to ensure they meet that year's federal priorities and requirements for the funding. Those projects selected by the Approval Authority are submitted to Cal OES for approval. Proposed projects may undergo modifications per Cal OES and FEMA feedback throughout the period of performance of the grant. This board letter grants the CEO, FIRE Department and OEM authority to submit the grant application, manage the grant program and make modifications to projects as needed to meet the grant requirements and be reimbursed by Cal OES.

The 2024 HSGP proposed projects listed below have been previously approved by Cal OES and the Approval Authority.
