

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE
COUNTY OF SANTA BARBARA, STATE OF CALIFORNIA**

**IN THE MATTER OF ESTABLISHING)
PARKING RESTRICTIONS)
ON VARIOUS COUNTY ROADS)
IN THE FIRST SUPERVISORIAL DISTRICT)**

RESOLUTION NO. 21-12

WHEREAS, California Vehicle Code Section 22507.5 and the Code of Santa Barbara County, California, Section 23-11, authorizes the Board of Supervisors of the County, to establish parking regulations on portions of roads and highways under its jurisdiction; and

WHEREAS, it is in the best interest of public safety that certain portions of County highways in Santa Barbara County be designated as no stopping, standing, or parking zones, in accordance with said Sections;

NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED, that the following locations in Santa Barbara County and under the jurisdiction of the Board of Supervisors of said County are hereby designated as no stopping, standing, or parking zones during certain times and that the Director of Public Works of the County of Santa Barbara is hereby authorized and directed to install and maintain appropriate pavement markings and signs at the following locations:

FIRST DISTRICT – Unincorporated Area of Summerland and Montecito

ADOPT

No Stopping, Standing or Parking Zone (2:00 a.m. to 6:00 a.m.)

- On the south side of Wallace Avenue from Evans Avenue to Finney Street.
- On the south side of Finney Street from Wallace Avenue to its easterly terminus.
- On the south side of Jameson Lane (South) from a point 68’ east of the centerline of Eucalyptus Lane to a point 690’ east of the centerline of Eucalyptus Lane.
- On the south side of Jameson Lane (South) from a point 1,277’ east of the centerline of Eucalyptus Lane to a point 1,405’ east of the centerline of Eucalyptus Lane.
- On the east side of Eucalyptus Lane from the centerline of Jameson Lane (South) to a point 230’ south of the centerline of Jameson Lane (South).

IT IS FURTHER RESOLVED that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to install appropriate markings and/or signs at said locations as time and resources permit.


