RESOLUTION NO. 19-122

RESOLUTION OF THE
BOARD OF SUPERVISORS OF THE COUNTY OF SANTA BARBARA,
STATE OF CALIFORNIA
APPROVING THE REQUEST OF THE ISLA VISTA COMMUNITY SERVICES
DISTRICT TO CONSOLIDATE ITS BOARD OF DIRECTOR ELECTIONS WITH THE
STATEWIDE GENERAL ELECTION

WHEREAS, the Isla Vista Community Services District ("District") is a special district as defined in the California Elections Code section 10404, and per Government Code section 61250 *et seq*; and

WHEREAS, the formation of the District established the election for its governing Board of Directors ("Board") members in November of odd-numbered years; and

WHEREAS, Elections Code section 10404 authorizes the District to move governance elections from odd-numbered years to even-numbered years via adoption of a resolution which, if approved, must then be submitted to the Santa Barbara County Board of Supervisors no later than 240 days prior to the currently scheduled election; and

WHEREAS, the District adopted Resolutions 19-2 and 19-3 to move its governance elections and petitioned the Board of Supervisors to accept and approve the resolutions thereby moving its elections of Board members to the Statewide General election held in even-numbered years for all future elections; and

WHEREAS, the Board of Supervisors outreached all districts in the County to determine the impact of this consolidation request on its districts, and received no input from the districts; and

WHEREAS, the Board of Supervisors has received an impact analysis of the proposed consolidation and a report from the county elections official on the cost-effectiveness and cost-savings to this District by consolidating its election and reducing the proportional share of cost for all districts consolidating at the Statewide General election; and

WHEREAS, the county elections official and the Board of Supervisors have determined that consolidating an additional election will not create an issue with the ballot style, voting equipment or computer capacity to handle the additional consolidation.

NOW, THEREFORE, BE IT RESOLVED that:

1. The Board of Supervisors of the County of Santa Barbara hereby approves the request and resolutions of the Isla Vista Community Services District to consolidate its governing Board of Director elections with the Statewide General Election.
2. The county elections official is hereby authorized, instructed, and directed to provide and furnish any and all official ballots, notices, printed matter, and all supplies, equipment, and paraphernalia that may be necessary in order to properly and lawfully

conduct an election.

- 3. The county elections official is hereby further directed to take the necessary and appropriate actions to provide the necessary election officers, polling places, and voting precincts.
- 4. Notice of time and place of holding said election, together with any other notices required by law, shall be given by the county elections official.




