Recommended Actions:

That the Board of Supervisors:

- a) Approve the appointment of a new alternate representative to the Conservation Steering Committee for the California tiger salamander Regional Conservation Strategy project; and
- b) Approve the transposition of The Nature Conservancy's committee member with its alternate member.

Summary Text:

The Board of Supervisors has authority for appointing and modifying membership of the Conservation Steering Committee pursuant to procedures outlined in the *Guidelines for General Plan Advisory Committees and Similar Advisory Bodies* adopted by Resolution 91-211 of the Board of Supervisors on April 9, 1991. The purpose of this item is to appoint an alternate committee member to represent the development community on the Conservation Steering Committee for the Regional Conservation Strategy project. The nominated alternate is Laurie Tamura of Urban Planning Concepts. Additionally,

the Nature Conservancy, representing the environmental community, requests approval to transpose the committee member and the alternate committee member.

Background:

The Board of Supervisors initiated the development of a Regional Conservation Strategy on March 28, 2006 for the protection of the California tiger salamander. On April 24, 2007, the Board of Supervisors formed the Conservation Steering Committee (CSC) to advise staff in the development and implementation of the Regional Conservation Strategy draft plan, and approved Resolution No 07-096 (attached). At that time no alternate member representing development interests was identified. The purpose of this item is to appoint an alternate committee member. Additionally, approval of this item will allow the committee member and alternate member affiliated with The Nature Conservancy to switch positions. The amended list of representatives is:
