#### **Recommended Actions:**

That the Board of Supervisors set a public hearing for June 18, 2013 for 30 minutes to consider and adopt resolutions to establish fee schedules for County solid waste facility tipping fees, collection rates, and parcel fees for FY 13/14.

### **Summary Text:**

Each year, your Board adopts resolutions establishing fees charged at County-operated solid waste management facilities as well as rates charged by the franchised service providers to collect waste materials from residential and commercial customers. Lastly, your Board sets the parcel fee that is assessed to property owners in the New Cuyama Valley to pay for the operation of transfer stations in this rural community. These fees are developed and approved in accordance with Chapter 17 of the Santa Barbara County Code. A Board Letter will be submitted prior to the departmental hearing providing the proposed fee schedules for these services and will be available to the public on June 13, 2013 on the County Clerk of the Board's Website for the June 18<sup>th</sup> Board of Supervisors hearing and hard copies will be available at the Clerk of the Board office at 105 East Anapamu Street, Santa Barbara as well as the offices of the Resource Recovery & Waste Management Division at 130 East Victoria Street, Suite 100 in Santa Barbara.

## **Performance Measure:**

The tipping fees and collection rates are based on the cost to provide these solid waste management services.

There will be changes to the existing fee schedules and will be provided in detail in the subsequent Board Letter. There are no proposed facility impacts.
