WHEREAS, the County of Santa Barbara District Attorney desires to undertake a certain project designated as the Child Advocacy Center (KC) Program, to be funded in part from funds made available through the Governor's Office of Emergency Services (Cal OES); and

WHEREAS, the District Attorney is anticipating being awarded grant funding from Cal OES for the KC Program, subject to Board approval, in the amount of \$200,000, for the grant period of April 1, 2025 through March 31, 2026.

NOW, THEREFORE, BE IT RESOLVED that the District Attorney or his designee is authorized to apply for and accept grant funds and sign on behalf of the County of Santa Barbara a Grant Subaward Agreement for the KC Program, which includes the Grant Subaward Assurances, Program Standard Assurance Addendum, Standard Certification of Compliance, and Application Signatures Form for the period of April 1, 2025 through March 31, 2026 in the amount of \$200,000, including any amendments to the Grant Subaward Agreement extending the term thereof through September 30, 2026, or for a supplemental grant award in the amount not to exceed \$50,000.

BE IT FURTHER RESOLVED THAT IT IS AGREED that any liability arising out of the County of Santa Barbara District Attorney's performance of this KC Program, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The State of California and Cal OES disclaim responsibility of any such liability.

BE IT FURTHER RESOLVED that the applicant agrees to provide any matching funds required for said project (including any amendment thereof) under the KC Program and the funding terms and conditions of Cal OES, and that any cash match will be appropriated as required.

BE IT FURTHER RESOLVED that grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
