IN THE MATTER OF PROCLAIMING THE WEEK OF OCTOBER 3rd – 9th, 2004 "NATIONAL FIRE PREVENTION WEEK"

WHEREAS, OCTOBER 3 – 9th HAS BEEN DECLARED "NATIONAL FIRE PREVENTION WEEK", a time to reflect on our nation's past fire history, remembering the Great Chicago Fire of 1871" and how out of that tragedy, national interests in fire prevention and safety emerged; and

WHEREAS, smoke and poisonous gases are the leading causes of death in fires, and can kill a person long before the flames will; and

WHEREAS, underestimating the power of fire and the time it takes to escape a home fire put people at severe risk to fire death and injury; and

WHEREAS, developing a home fire escape plan and practicing it at least twice a year are critical to escaping a fire safely; and

WHEREAS, a complete home escape plan includes everyone in the household knowing two ways out of each room, having an outdoor location where everyone will meet upon exiting the home, remembering to call 911 from a neighbor's **home phone**; and

WHEREAS, fire prevention and safety is everyone's responsibility; and

WHEREAS, the 2004 Fire Prevention Week theme, "*Test Your Smoke Alarms*", emphasizes the importance of not only having a smoke alarm, but testing it regularly; and

WHEREAS, the Santa Barbara County Fire Department is dedicated to the safety of life and property from the devastating effects of fire;

NOW, THEREFORE, BE AND IT IS HEREBY ORDERED AND RESOLVED AS FOLLOWS:

- 1. The week of October 3-9th is proclaimed "National Fire Prevention Week" throughout Santa Barbara County.
- 2. In support of our fire service agencies, we encourage everyone to participate in fire prevention activities in the community, at home, at work and at school.
- 3. We encourage parents to test smoke alarms once a month be sure they're working.
- 4. Make this Fire Prevention Week the beginning to a yearlong effort to improve fire safety wherever you are.
