**FIRST AMENDMENT TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

First Amendment

This is a *First Amendment* (*First Amendment to the Agreement*) to the Agreement for Services of Independent Contractor, number *BC#17202* by and between the **County of Santa Barbara** (COUNTY) and **DataWorks Plus** (CONTRACTOR).

WHEREAS, on September 30, 2016 COUNTY approved the Agreement for Services of Independent Contractor, number BC#1600739, (Agreement) with CONTRACTOR for Livescan ID equipment implantation, maintenance and support of ID Software Systems;

WHEREAS, the initial term of the Agreement commenced on September 30, 2016, and expired on September 30, 2021; and

WHEREAS, the parties now desire to amend Agreement to extend the term for additional years commencing on October 1, 2021, through September 7, 2024 (First Extension Period).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows.

The Agreement is amended as follows:

1. Section 3 of the Agreement is amended by adding the following language:

For the First Extension Period, CONTRACTOR shall commence performance on **October 1, 2021** and end performance upon completion, but no later than **September 7, 2024** unless otherwise directed by COUNTY or unless earlier terminated. The COUNTY upon completion of performance and full compensation to the CONTRACTOR will post a new Request for Proposal of which the CONTRACTOR can submit new bid for continuation of services.

In all other respects, the Agreement remains unchanged.
