# **RECOMMENDATIONS:**

C.A. Recommendation:\_\_\_\_\_

That the Board of Supervisors consider recommendations regarding parking zones in the Orcutt area, Fourth District, as follows:

- A) Adopt a resolution rescinding Resolutions No. 73-717, 74-106, 94-14 and 94-15 which established no parking and passenger loading zones on Dickson Drive;
- B) Adopt a resolution establishing no parking and time limited no parking zones on Dickson Drive.

## ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

#### **EXECUTIVE SUMMARY & DISCUSSION:**

Dickson Drive is a residential street in the Orcutt area. Joe Nightingale School is located at the corner of Winter Road and Dickson Drive. Currently there is a painted crosswalk on Dickson Drive at Vineland Drive. Also the school buses for Nightingale School drop off and pick up on the west side of Dickson Drive north of Winter Road. The school's principal has requested additional no parking at the painted crosswalk on Dickson Drive at Vineland Drive for visibility. Staff investigated the site and it was determined that the no parking zone for the painted crosswalk needs to be updated, and a time limited no parking zone be established for use by the school buses. The Public Works Traffic Section has prepared the attached resolution to rescind the old resolutions and establish no parking and time limited no parking zones at the following locations:

## **NO PARKING**

- a) On the east side of Dickson Drive between the centerline of Vineland Drive and a point 90 feet south of the centerline of Vineland Drive
- b) On the west side of Dickson Drive between a point 40 feet north of the centerline of Vineland Drive and a point 70 feet south of the centerline of Vineland Drive
