FIRST AMENDMENT TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

This First Amendment to Agreement for Services of Independent Contractor (the "Amendment") is entered into between the County of Santa Barbara (hereafter "COUNTY") and Gold Coast Recycling, Incorporated (hereafter "CONTRACTOR"). This Amendment, modifies and is incorporated into the contract between the COUNTY and CONTRACTOR for the processing of commingled recyclables, dated June 16, 2020 (collectively referred to hereafter as the "Agreement").

NOW THEREFORE, COUNTY and CONTRACTOR agree to amend the Agreement as follows:

- Replace Section 4. TERM with the following paragraph:
 CONTRACTOR shall commence performance on July 1, 2020 and end performance upon completion, but no later than June 30, 2021 unless otherwise directed by the COUNTY or unless earlier terminated.
- Replace Exhibit B, Section A with the following paragraph:
 For CONTRACTOR services to be rendered under this agreement,
 CONTRACTOR shall be paid a total contract amount, including processing fees,
 not to exceed \$1,300,000.
- 3. Replace Exhibit B1, Section B, first paragraph with the following paragraph: PAYMENT DETAILS: Monthly, COUNTY shall pay to the CONTRACTOR the processing fee according to the schedule listed above in Section A. 1.; however, total invoicing to the County for this contract may not exceed \$1,300,000.
