Recommended Actions:

That the Board of Supervisors:

- 1. Receive report and provide staff with direction about any recommended changes to the County's Draft 2015 Legislative Platform.
- 2. Find that the proposed actions do not constitute a "Project" within the meaning of California Environmental Quality Act, pursuant to 14 CCR 15378(b)(2), as it consists of general policy and procedure making.

Summary Text:

The Legislative Program Committee has forwarded the 2015 Legislative Development Plan, the 2015 Legislative Principles, and the Draft 2015 Legislative Platform (Funding Request, Legislative, and Targeted Advocacy planks) for review, discussion and recommendations for possible changes. Review of the platform planks has been provided to the Board and now complete review of the platform is provided for consideration, with final approval in January. These review steps were recommended by the Board during the deliberations on the 2014 Legislative Platform. Any changes approved by Board action will be made by staff and final changes reviewed prior to consideration by the Legislative Program Committee. The 2015 Legislative Platform will be brought back for consideration and possible final adoption at the Board's January 13, 2015 meeting.

After initial reviews, the Board has requested additions and changes to the platform that include: adding the Carpinteria Veterans Building to the Veterans Memorial Buildings plank, addition of a Water Quality monitoring plank, a plank to advocate for AB 109 funding, the addition of a Seismic Testing funding plank, and the review of the platform by the Agricultural Advisory Committee (AAC). plank additions are now included with the draft platform and AAC input is attached. All of these requests and recommendations are provided for this Draft Platform review.

Each year, the County identifies specific issues, projects and/or programs ("priorities") to include within the County's legislative platform. Once adopted by the Board of Supervisors, the 2015 Legislative Platform ("platform") will be used by the County to communicate the County's priorities to the federal and state governments.

Background:

The development of the Draft 2015 Legislative Platform began in August when the County's Legislative Program Committee ("Committee") reviewed the legislative principles. During the development of the platform, County staff also discussed potential issues and projects with its federal and state delegation and began designing a legislative strategy. Strategies involve funding requests, crafting new or amending existing legislation and advocacy of program and grant funding and regulatory reform. Following Board adoption of the 2015 Legislative Platform, it will be used to communicate the County's priorities to the federal and state officials as well as other intergovernmental entities.

The Committee is continuing to recommend legislative principles, including the following:

- Job Growth/Economic Vitality
- Efficient Service Delivery/Operations
- Fiscal Stability

- Interagency Collaboration
- Local Control
- Health and Human Services
- Community Sustainability

The Committee is recommending the Board consider positions on 34 individual platform planks that align with the legislative principles listed above. Each of the Draft 2015 Legislative Platform planks can be categorized as a funding request, legislative proposal and/or targeted advocacy. County staff works closely with our state and federal advocates and partners to develop effective strategies to address the countywide needs as well as effective strategies to address platform items.
