Justification:

First 5 California awarded First 5 Santa Barbara County (F5SBC) \$99,942.10 to rebuild and strengthen home visiting programs and embed home visiting into other systems of child and family support that are critical to recovery from the COVID-19 crisis. F5SBC can use this one-time funding through June 30, 2022.
