Title:

General Services Acceptance of Grant for three (3) Electric Vehicle Charging Stations

Budget Action: Increase appropriations of \$35,130 in the General Services, Utilities Fund for Capital Assets - equipment, funded by a grant from the California Energy Commission

Justification:

Justification: The County of Santa Barbara has been awarded a grant of \$35,130 for three (3) electric vehicle charging stations with ChargePoint America through a grant from the California Energy Commission (CEC) at no initial cost to the County. The grant will provide funding for material and installation costs for the new charging stations. The grant requires that the three (3) charging stations be made accessible to the public until January 1, 2016. The public will be charged via the ChargePoint Network based on the amount of electricity consumed per charging session, and a portion of this rate charged will be reimbursed to the County to help offset electricity costs incurred while operating the charging stations. This is the current process being utilized for existing County EV charging stations. The County of Santa Barbara will pay a two year subscription fee of \$2,760 for the ChargePoint Network Commercial Service Plan. This budget revision will establish the budgetary framework to accept the grant and increase fixed asset appropriations.
