**RECOMMENDATIONS:**

C.A. Recommendation: \_\_\_\_\_

That the Board of Supervisors adopt a resolution establishing a “No Parking” zone on Hope Avenue, south of State Route 192 in the Santa Barbara area.

**ALIGNMENT WITH BOARD STRATEGIC PLAN:**

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

**EXECUTIVE SUMMARY & DISCUSSION:**

Hope Avenue is located south of Foothill Road in the Santa Barbara area. It is a 32-foot wide residential road that runs between State Route 192 and Highway 101.

Monte Vista Elementary School is located on the east side of Hope Avenue, between State Route 192 and State Street. Vehicles parked on this side of the roadway create a sight distance problem for children who use the school crosswalk. There is adequate parking to accommodate the residents in the surrounding area. In order to improve the safety for the children who attend Monte Vista Elementary school, the Public Works Traffic Section recommends the establishment of a “No Parking” zone at the following location:

On the east side of Hope Avenue, from a point 85 feet south of the centerline of Center Avenue to a point 147 feet south of the centerline of Center Avenue.
