## RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SANTA BARBARA, STATE OF CALIFORNIA

IN THE MATTER OF RESCINDING PORTION OF RESOLUTION No. 25-100 AND ESTABLISHING NO PARKING OF OVERSIZED VEHICLES ON VARIOUS COUNTY ROADS IN THE FIRST AND SECOND SUPERVISORIAL DISTRICTS

RESOLUTION NO.	

WHEREAS, California Vehicle Code Sections 22507 and 22507.5 and the Code of Santa Barbara County, California, Section 23-11, authorize the Board of Supervisors of the County, to establish parking regulations on portions of roads and highways under its jurisdiction; and WHEREAS, the Board of Supervisors on May 13, 2025, adopted Resolution No. 25-100 which established no parking, stopping, or standing of oversized vehicles on various roads; and WHEREAS, many of the adopted roads were in the coastal zone which may impair public parking for coastal access; and

**WHEREAS**, it is in the best interest of public health and safety that certain portions of County highways in Santa Barbara County be designated as no parking of oversized vehicles but only overnight between 10:00 P.M. to 5:00 A.M.; and

**WHEREAS**, an oversized vehicle has been defined in Section 23-11(l)(1) as any motor vehicle, boat, or trailer which exceeds at least one of the following criteria: twenty-four feet in length; seven feet in height; or eight feet in width; and

**WHEREAS**, these restrictions shall not apply to any service vehicle owned or operated by or for or operated under contract with a public agency or utility, whether privately, municipally, or publicly owned, used in the construction, operation, removal, or repair of utility or public facilities, nor any transportation vehicles actively being used for public transit, nor any vehicle actively being used for the delivery of goods or services; and

**WHEREAS**, signs or markings giving adequate notice of oversized parking restrictions will be placed only at locations approved by the Board of Supervisors; and

**NOW, THEREFORE, IT IS HEREBY ORDERED AND RESOLVED** that a portion of Resolution No. 25-100 which established a no parking, stopping, or standing of oversized vehicles at the following locations is rescinded:
