## **ECONOMIC TREND**

---

- **The Federal Open Market Committee (Committee) decided to raise the target federal funds rate to a range of 0.50% to 0.75% at its December meeting.**
- **As summarized in the Beige Book issued January 18, 2017, reports from the twelve Federal Reserve Districts suggest national economic activity continued to expand at a modest pace across most regions during the reporting period from late November through the end of the year.**
- **Labor market conditions were reported to be tight or tightening during the period. Employment growth ranged from slight to moderate, and most districts indicated that wages increased modestly.**

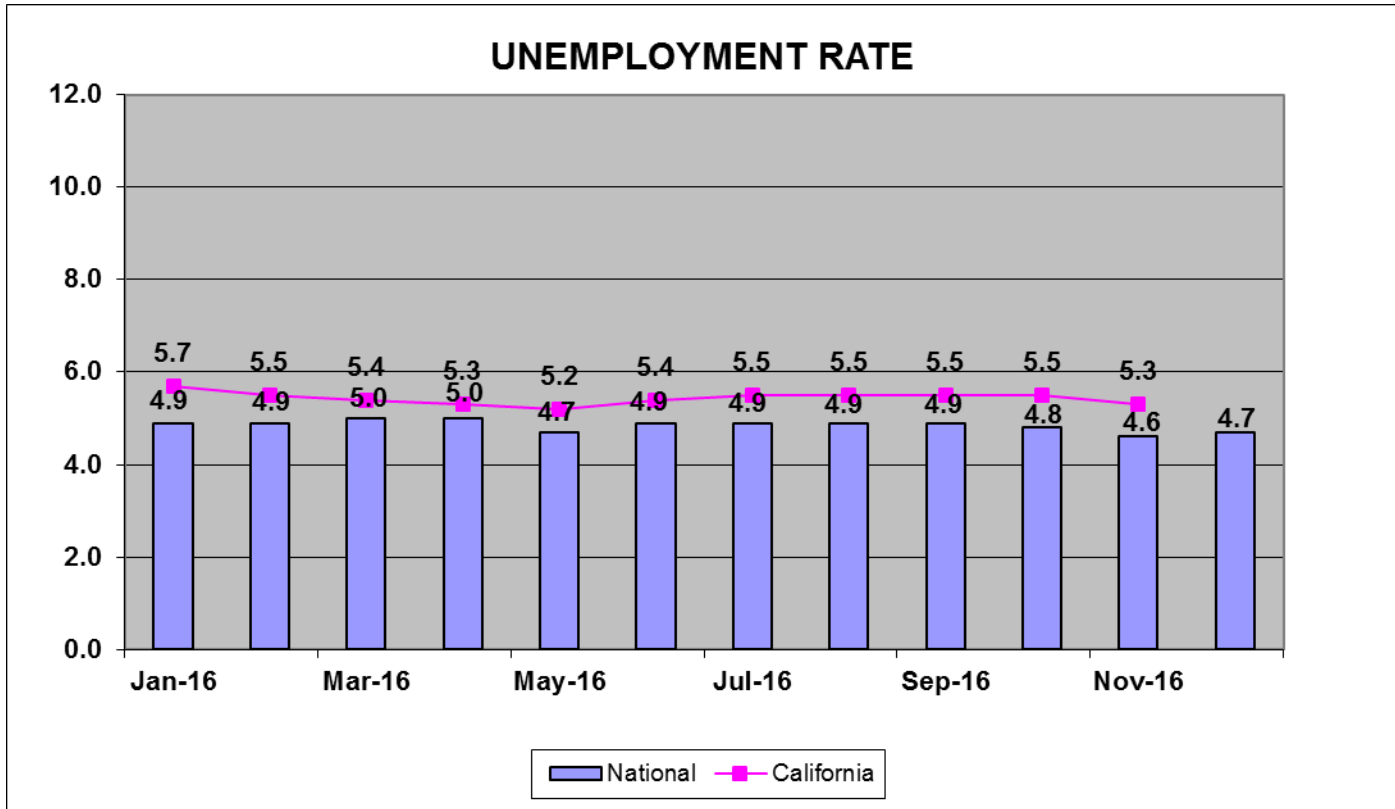
## **INVESTMENT ACTIVITIES**

## ECONOMIC TREND: Unemployment Rate

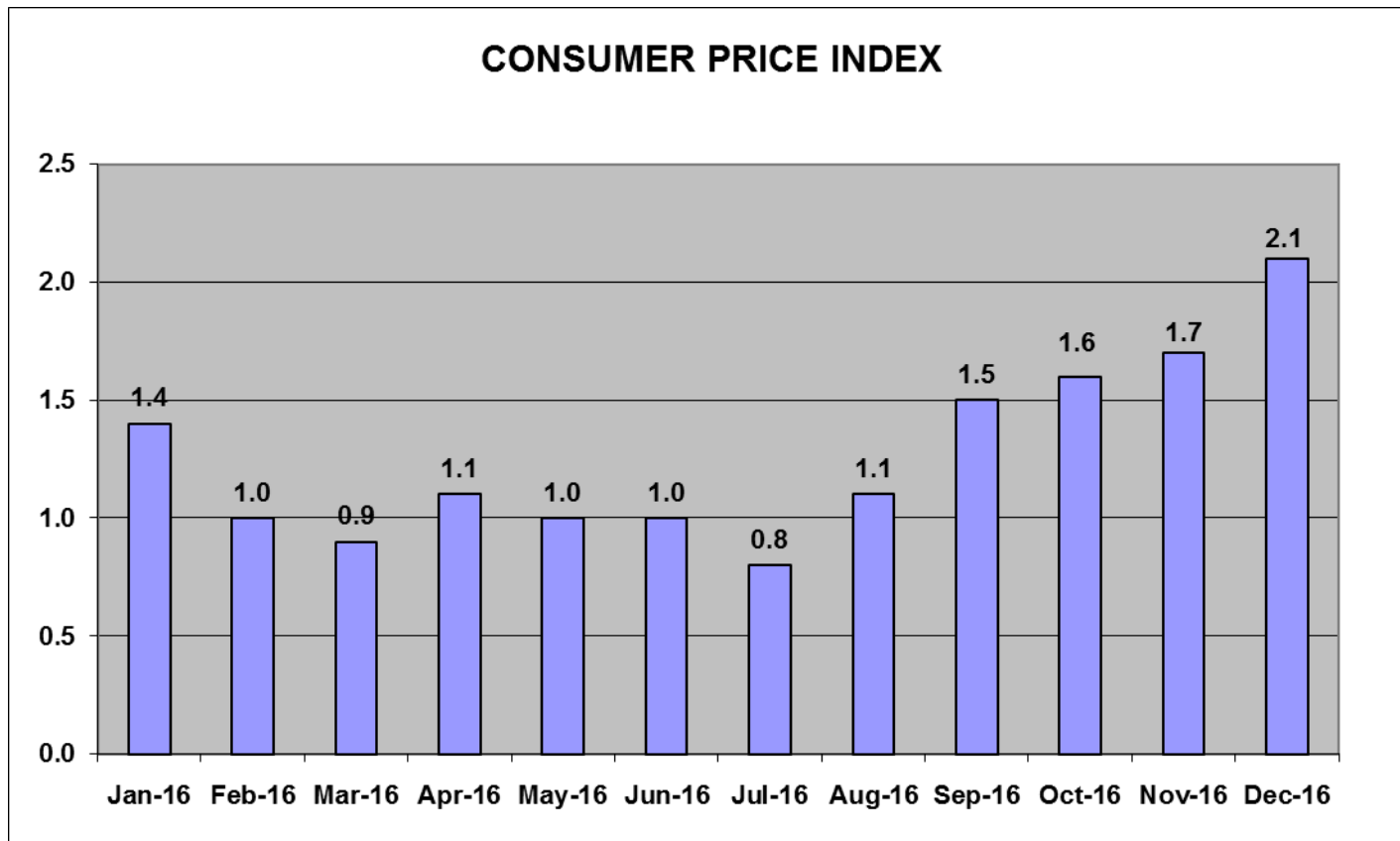
The unemployment rate represents the number of unemployed persons as a percent of the labor force. The sampling used each month to calculate the rate is approximately 60,000 households. The national unemployment rate began the quarter at 4.9% and ended the quarter at 4.7%. California's preliminary unemployment rate was 5.3% in November.

## ECONOMIC TREND: Inflation

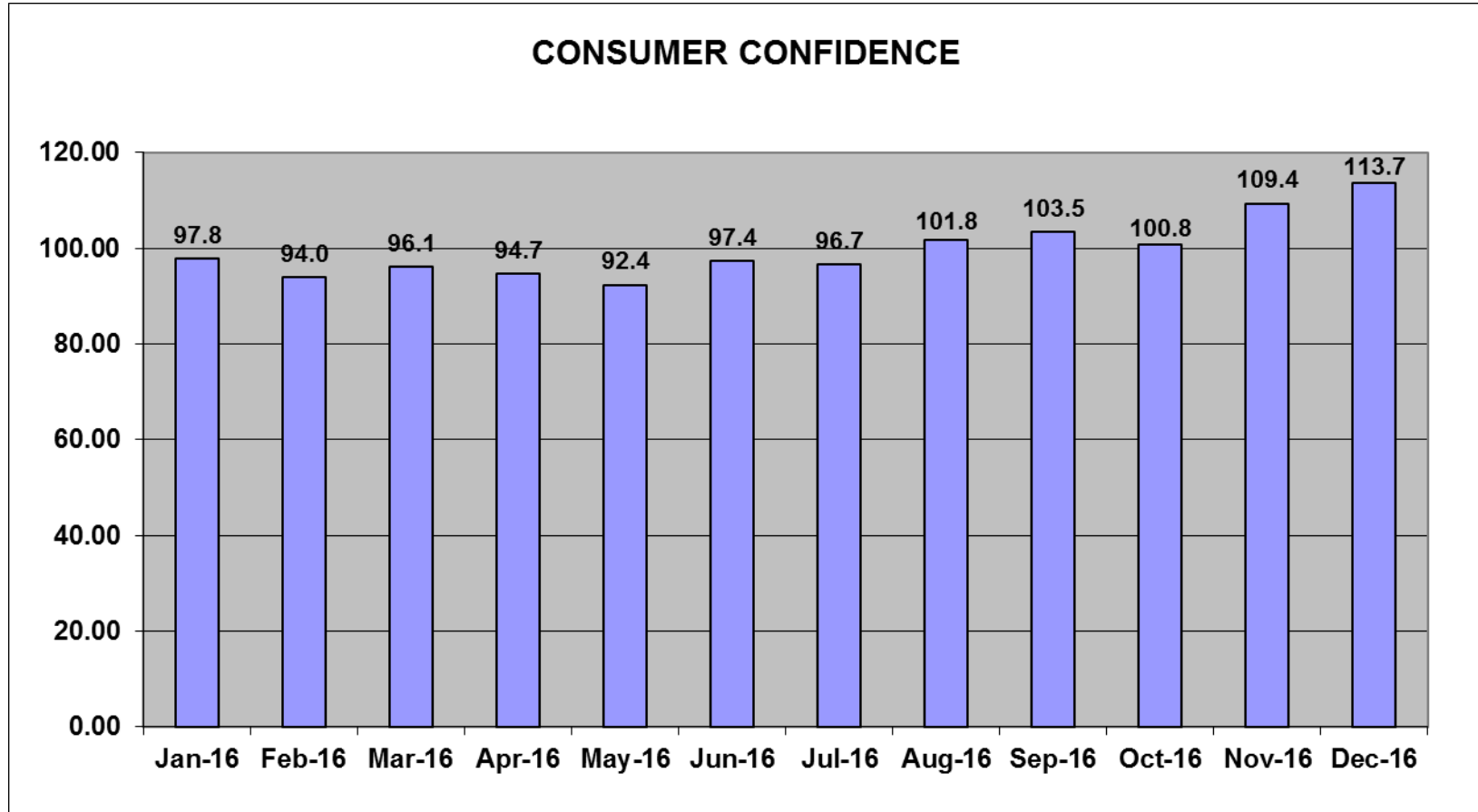

## ECONOMIC TREND: Consumer Confidence

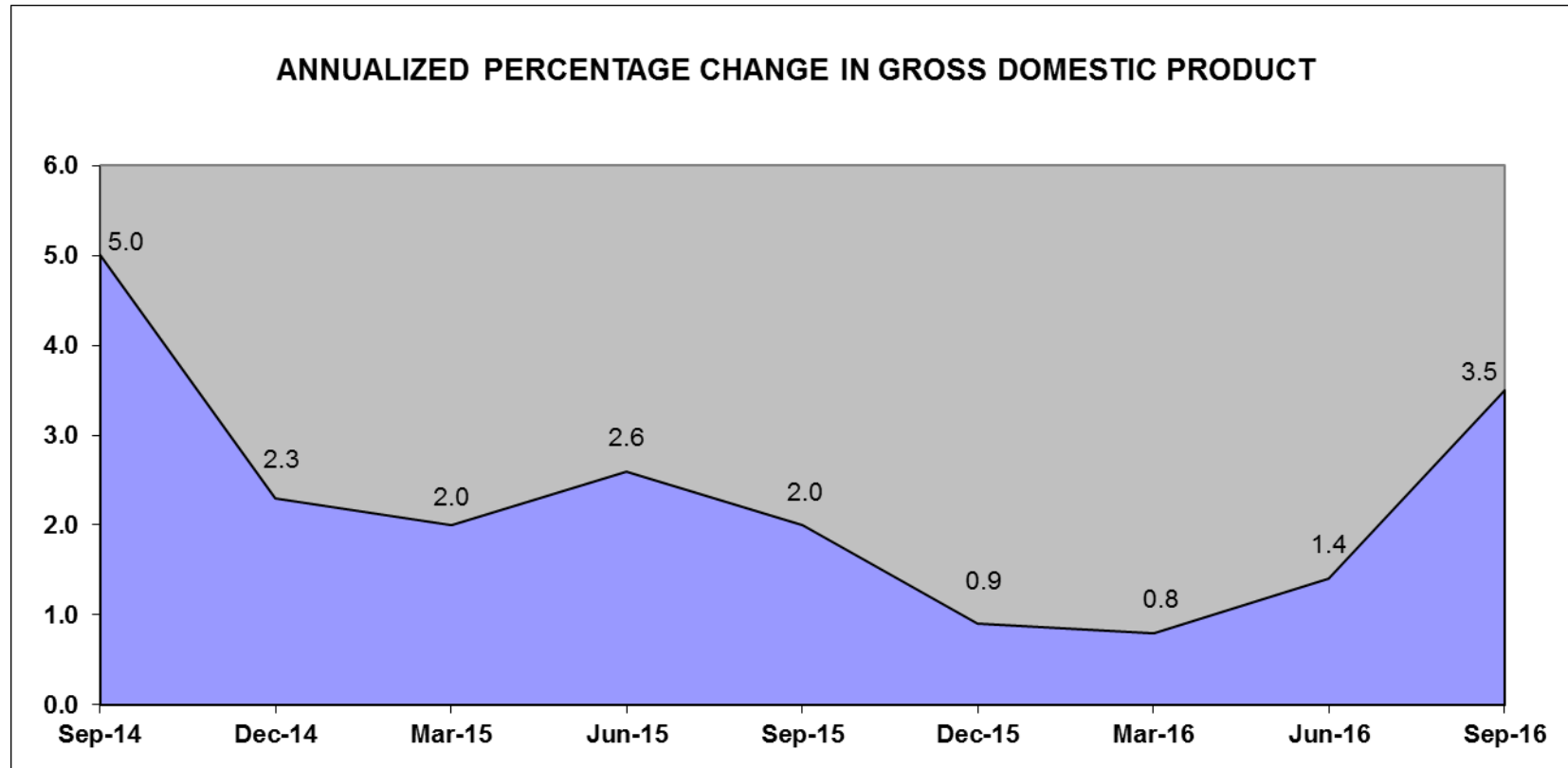
*Consumer Confidence is the average of responses to current business and employment conditions and responses to six-month future expectations for business conditions, employment conditions, and total family income. It began the quarter at 103.5 and ended at 113.7.*

## ECONOMIC TREND: GDP (Gross Domestic Product)

Gross domestic product is the value of all goods and services produced. After eighteen consecutive quarters of growth, the economy experienced its first quarter in negative territory ending March 2014 at -0.9%. Subsequently, the economy continued to recover. For the most recent quarter ending September 2016, the economy reported GDP at 3.5%.

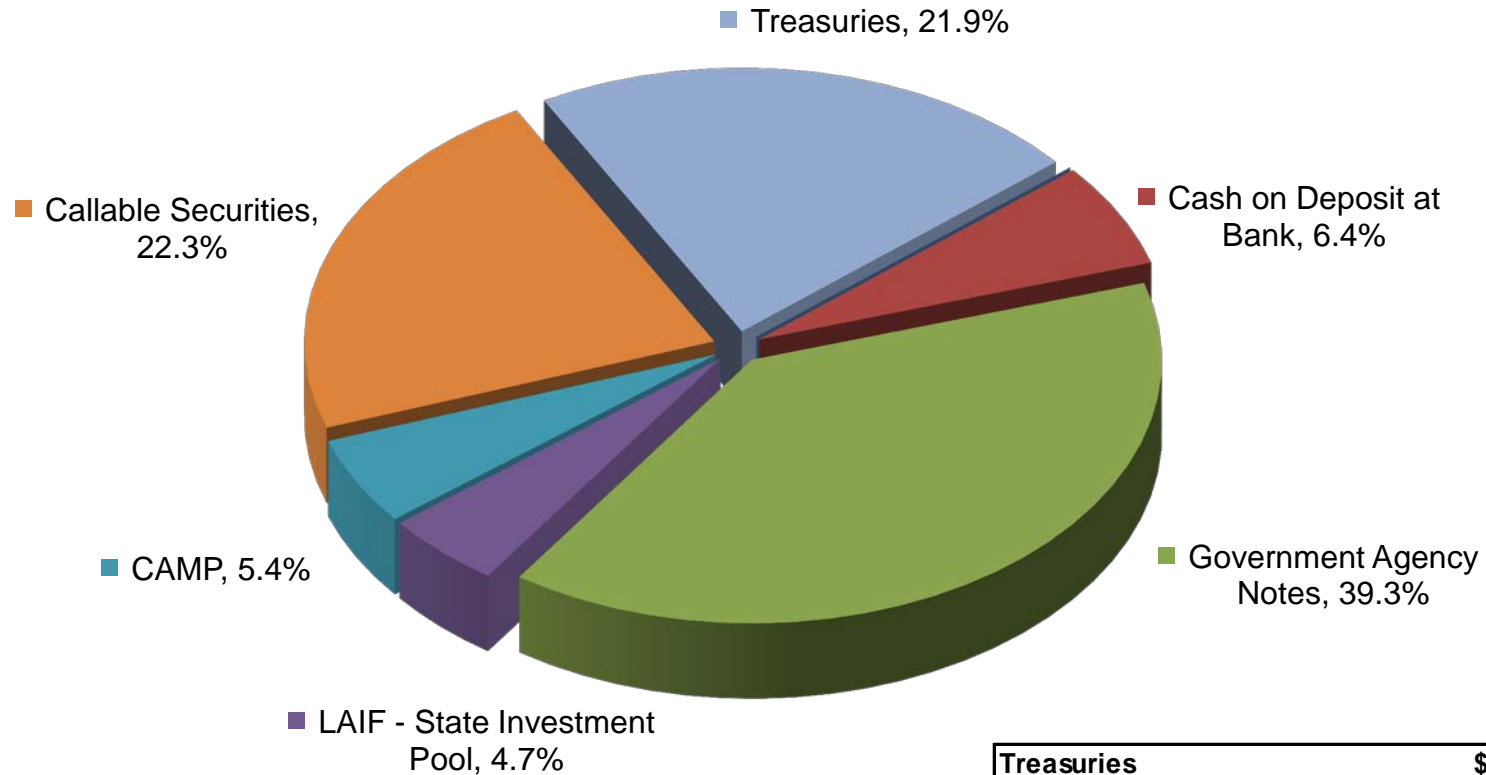

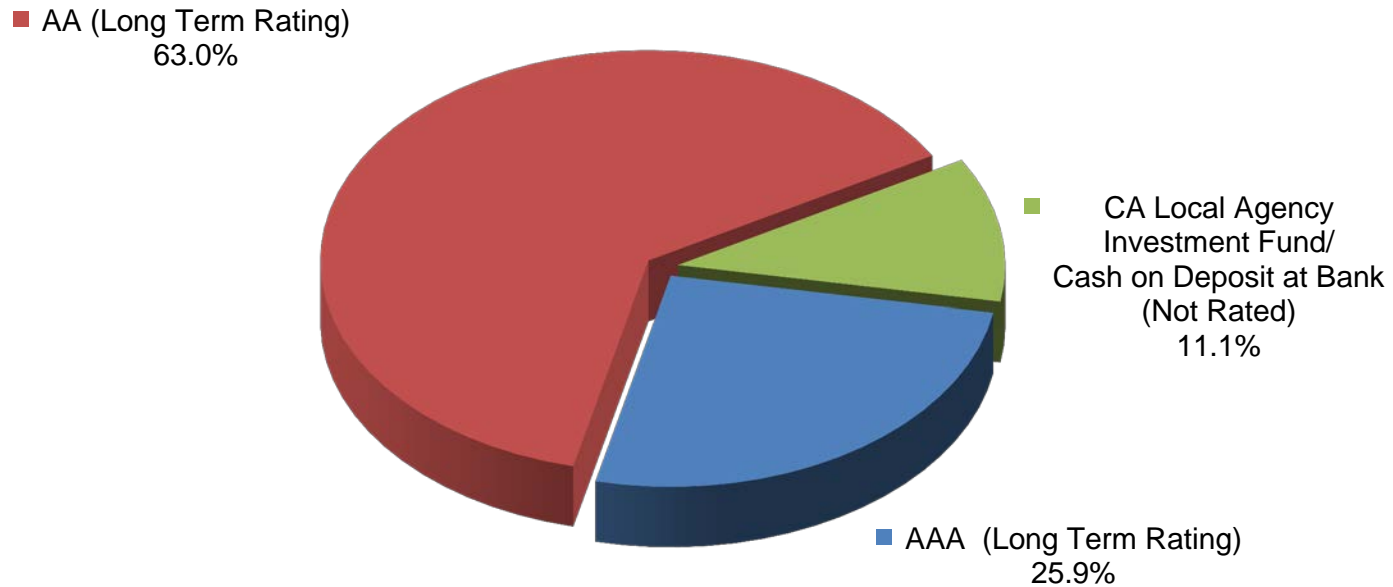
## TREASURER'S INVESTMENT POOL ASSET DISTRIBUTION BY SECTOR (PAR VALUE) 12/31/2016

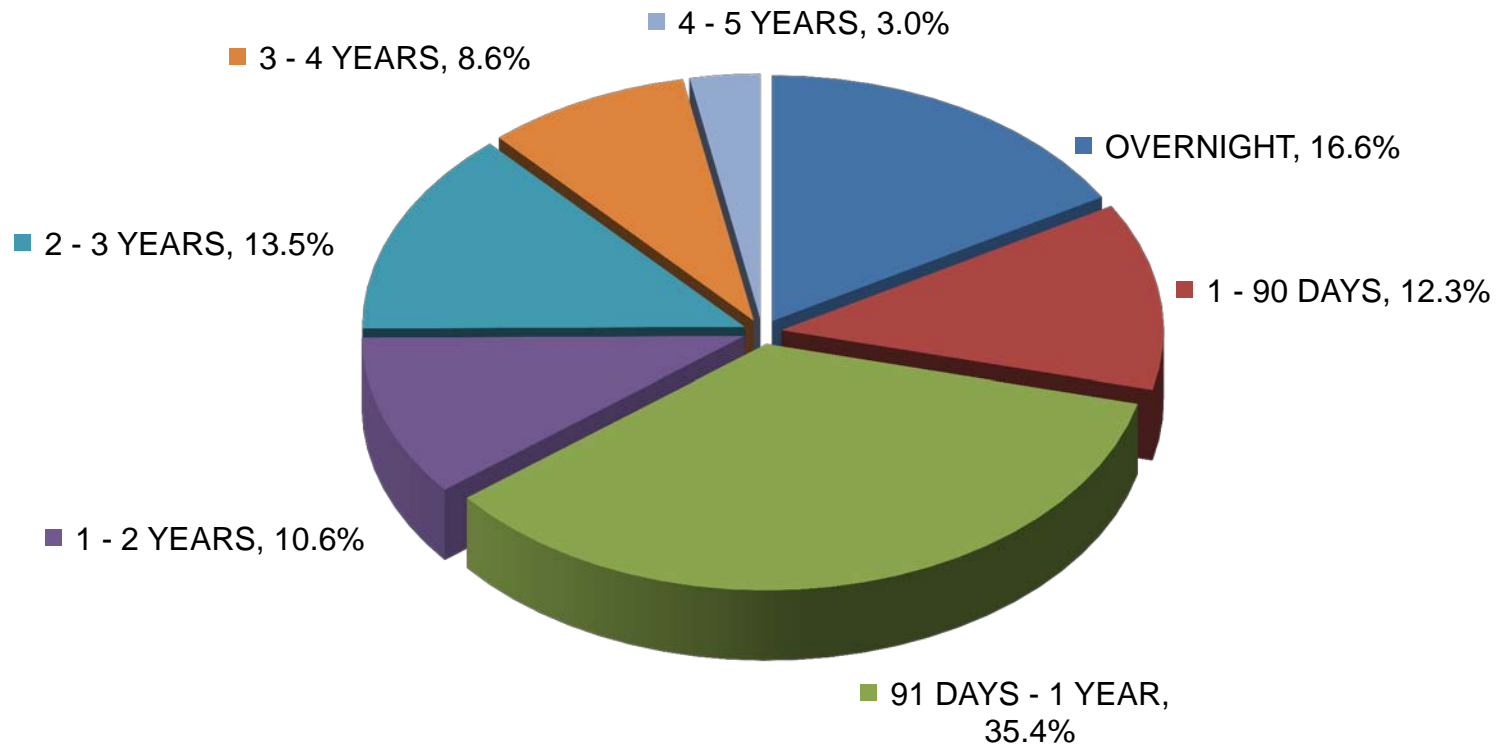
## S&P CREDIT RATING AT TIME OF PURCHASE BY PERCENT OF BOOK VALUE 12/31/2016



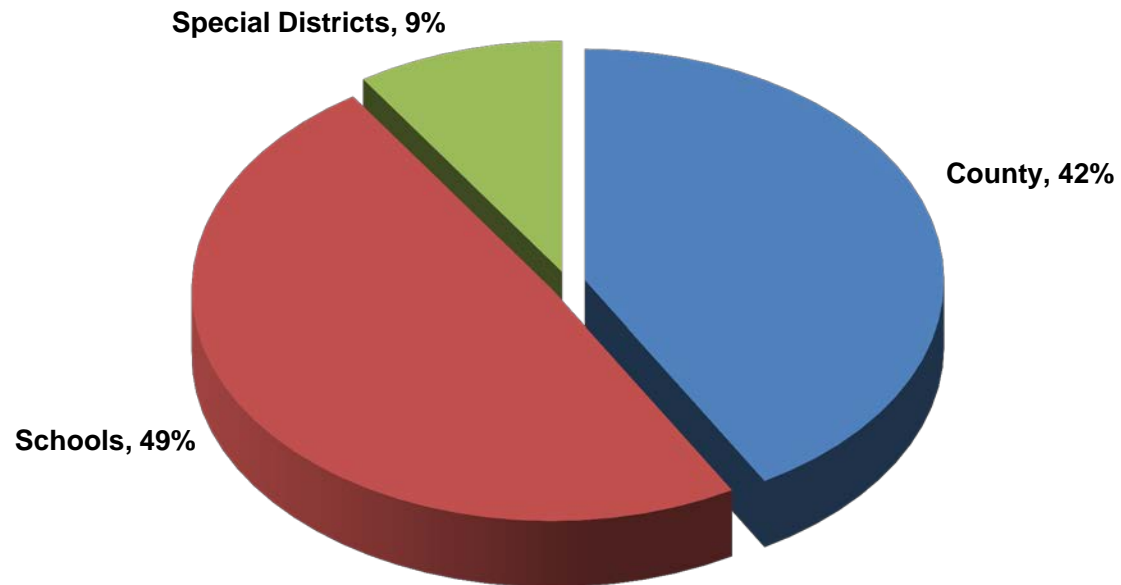

12/31/2016**

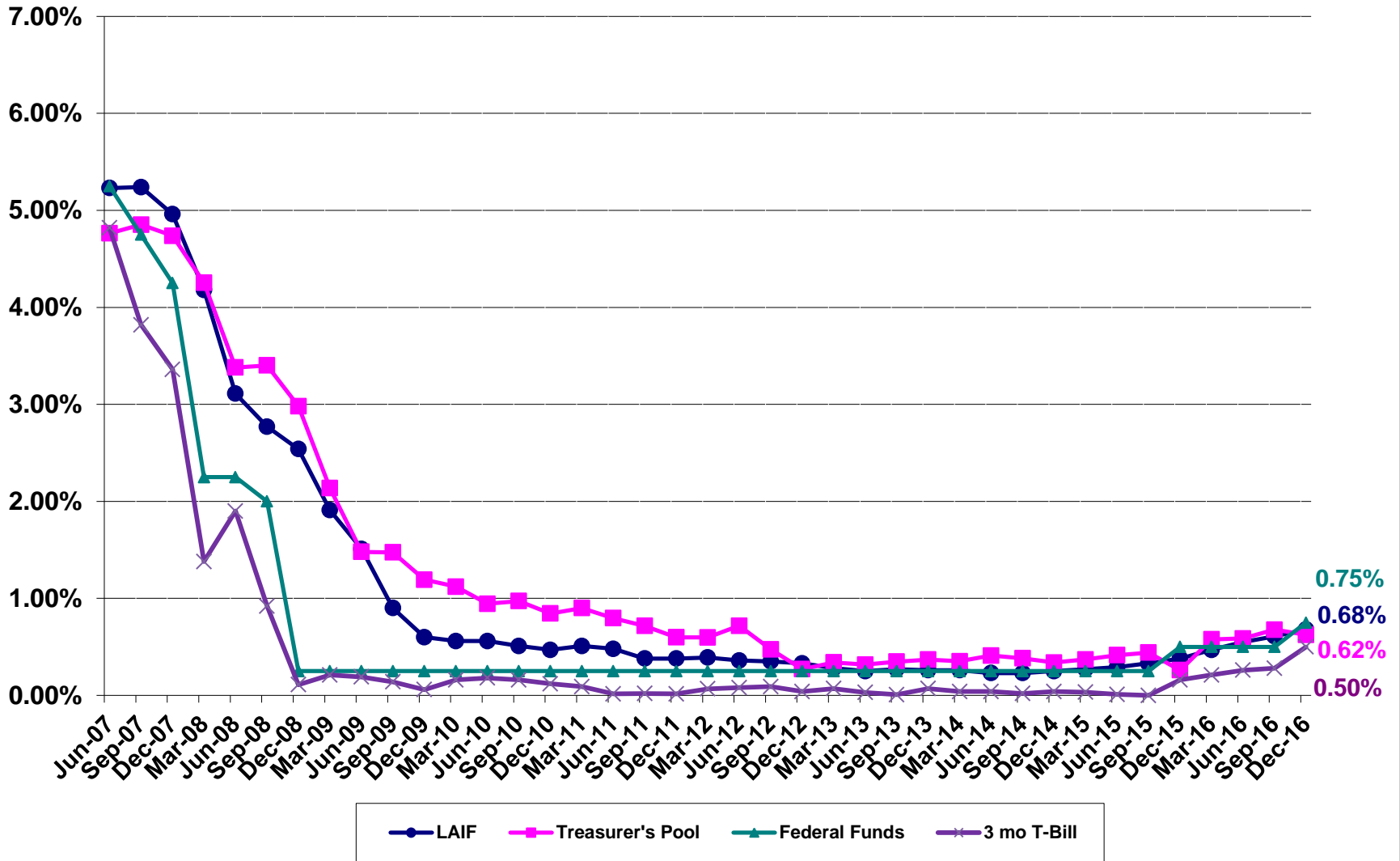


**TREASURER'S INVESTMENT POOL
