That the Board of Supervisors:

Adopt a Resolution Authorizing the College Elementary School District to Issue and Sell Bonds in its Own Behalf in Accordance with Education Code Section 15140 in an amount not to exceed \$2.33 million.

Summary Text:

As to form: Yes

On November 2, 2004 the requisite 55% of qualified voters in the College Elementary School District authorized the District to issue General Obligation bonds in an amount not to exceed \$9.4 million.

Background:

On December 21, 2004 and on May 10, 2006 the District issued \$4.75 million and \$2.3 million, respectively, of the College Elementary School District, General Obligation Bonds, Election of 2004. Accordingly, \$7.07 million of the voter approved \$9.4 million has already been issued.

The District is preparing to issue the bonds, "College Elementary School District, Election of 2004 General Obligation Bonds, Series 2009" in the amount of \$2.33 million, which is the remainder of the \$9.4 million authorized by the voters in "Measure Z2004" on November 2, 2004.

The College Elementary School District will be liable for repayment of the bonds and they have received a positive certification in their most recent interim report, the "Second Interim for the 2008 – 2009 School Year", dated March 10, 2009. Santa Barbara County will levy and collect the taxes and make the payments, as required by Code Section 15140 (b).

A Citizen's Bond Oversight Committee, pursuant to EC 15278 has been established by the District.
