#### **Recommended Actions:**

That the Board of Supervisors consider the following recommendations:

- a) Approve and authorize the Chair to execute a Amendment No. 1 (Attachment A) to the Cooperative Agreement (Attachment B) by and among The Regents of the University of California, a California public corporation, on behalf of the University of California, Santa Barbara, the City of Goleta, and the County of Santa Barbara, to make a minor revision to allow certain facilities to be placed in a road right of way and;
- b) Determine that the proposed action does not constitute a "Project" within the meaning of California Environmental Quality Act (CEQA), pursuant to Section 15378(b)(4) of the CEQA Guidelines, because it consists of the creation of a government funding mechanism or other government fiscal activities, which does not involve any commitment to any specific project which may result in a potentially significant impact on the environment.

#### **Summary Text:**

This item is on the agenda to request approval of an amendment to the Cooperative Agreement (hereby "Agreement") by and among The Regents of the University of California, a California public corporation, on behalf of the University of California, Santa Barbara (the "University"), the City of Goleta (the "City"), and the County of Santa Barbara (the "County"). The amendment will allow certain facilities to be placed in a road right of way easement along northwest border of University property near Phelps Road.

# **Background:**

The Agreement dated November 16, 2006 was effective April 3, 2008 in furtherance of the University's proposed faculty and family student housing projects identified in the North and West Campuses 2006 Long Range Development Plan Amendment and associated Notice of Impending Development and Coastal Development Permit which have been approved by the California Coastal Commission.

Approval of the Amendment will allow the University to place certain facilities in the road right of way easement enumerated in Section 5 of the Agreement along northwest border of University property near Phelps Road. These include concrete pads for the purpose of placing air conditioning condensers, overhangs with post elements attached to a building for the purpose of architectural treatment, and roof eave overhangs and bay window projections. The Agreement identifies that the right of way in question is an easement formerly held by the County, that was transferred to the City upon its incorporation in 2002. In 2012, by Resolution No. 12-56, the City summarily vacated the easement. The Amendment to the Agreement is limited to this minor revision. Although the right of way at issue is not a County easement or right of way, the Agreement may only be amended if signed by each party to the Agreement, including the County.
