SUBJECT: Speed Zones – San Marcos Road and Calle Real; Second and Third Supervisorial Districts.

RECOMMENDATIONS:

C.A. Recommendation:

That the Board of Supervisors:

- A. Set a public hearing for **April 3, 2001** to consider introduction of an ordinance amending Chapter 23, Sections 23-15.2 through 23-15.5, of the Code of Santa Barbara County, pertaining to speed limits on certain County Roads described herein.
- B. Conduct a second hearing on **April 17, 2001** and adopt the attached ordinance, amending Chapter 23, Article II, Sections 23-15.2 through 23-15.5, of the Code of Santa Barbara County, pertaining to speed limits on the subject roads described herein.

ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with the following Goals: #2) Ensure the Public Health and Safety and Provide Essential Infrastructure, and #5) Maintain and Enhance the Quality of Life for all Residents.

EXECUTIVE SUMMARY & DISCUSSION:

All recommended changes will be enforceable by radar, in compliance with State law, including AB 2767, which went into effect on January 1, 2001. AB 2767 allows for a further reduction in speed of 5 mph if certain conditions are present.

Therefore, in accordance with the California Vehicle Code, the Public Works Department recommends lowering the speed limit at the following locations:

San Marcos	from Calle Real to La Ramada	35	38	30

The changes of speed limits pertain to the following roads:

Delete from 35 mph Designation:

- San Marcos Road between Calle Real and La Ramada Road.
- San Marcos Road between La Ramada Road and Cathedral Oaks Road.
- Calle Real between Winchester Canyon Road and 300 feet east of Brandon Drive.

Add to 30 mph Designation:

- San Marcos Road between Calle Real and Cathedral Oaks Road.
- Calle Real between Winchester Canyon Road and 300 feet east of Brandon Drive.

Delete from 45 mph Designation:

• Calle Real between Turnpike Road and State Route 154.

Add to 40 mph Designation:

• Calle Real between El Sueno Road and State Route 154.

Add to 45 mph Designation:

• Calle Real between Turnpike Road and El Sueno Road.

MANDATES & SERVICE LEVELS:

No mandates or service levels are affected by this action.

FACILITIES AND FISCAL IMPACT:

Approximately \$300.00 will be required to post ten signs. Funding is available in the County Public Works Department Budget No. 054, Fund 0015, Program 2200, and Account No. 7121.
