Title: Recognize Property Tax revenue and Increase Committed Fund Balance for Managers equity adjustment

Budget Action: Establish appropriation of \$26,800 in General County Programs, General Fund to increase Committed Fund Balance for Managers equity adjustment, funded by an Intrafund Expenditure Transfer. Establish appropriation of \$26,800 in General Revenues, General Fund to increase Intrafund Expenditure Transfers,

funded by unanticipated Property Tax Revenues.

Justification: During the June 2014 Budget Hearings, the Board was informed that the final tax roll was higher than that included in the budget. The additional property tax revenue from the final tax roll is estimated to be \$2.3 million. The Board authorized \$620 thousand be recognized during the Budget Hearings, leaving

revenue from the final tax roll is estimated to be \$2.3 million. The Board authorized \$620 thousand be recognized during the Budget Hearings, leaving approximately \$1.7 million remaining for current or future years appropriation. This budget revision requests to appropriate the required General Funds for the

current year.

The balance of the required funding would be provided by the departments; utilizing Federal, State, Charges for Services or other revenue sources within their department. Salary and Benefit adjustments may be necessary in the future; however, most departments have salary savings that may absorb the increased costs to the department. Departments would return with individual budget revision request(s) as necessary based on actual results.
