Recommended Actions:

That the Board of Supervisors:

- a) Approve, ratify, and authorize the Chair of the Board of Supervisors to execute a Shelter Operations General Fund Agreement with Good Samaritan Shelter to support and maintain service levels at the Santa Maria Emergency Shelter, Family Emergency Shelter and Bridgehouse Emergency Shelter, for the period of July 1, 2018 through June 30, 2019 in an amount not to exceed \$242,793 (Attachment A);
- b) Determine that the recommended actions are not the acceptance and approval of a project that is subject to environmental review under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15378(b)(4), finding that the project is a creation of government funding mechanisms or other government fiscal activities, which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment.

Summary Text:

In the FY 2018-19 budget, the Board approved \$345,000 and \$50,000 in General Fund contribution toward the operation of four homeless shelters in North and South County and the Unitarian Society's Freedom

Warming Centers, respectively. The GSS Bridgehouse Shelter bed night utilization increased resulting in a recommended allocation of 25.37% of the total General Fund 2018-19 shelter operations funding. The 2018-19 recommended allocation, of \$87,532, detailed in the chart below is a 16.56% increase in the amount to the Bridgehouse Shelter between 2017-18 and 2018-19. A deviation greater than 10% requires Board approval to amend the renewed Board Contract for the 2018-19 agreement. Staff also recommends that bed night data from the three Good Samaritan Shelters, located in Lompoc and Santa Maria, be aggregated and assessed as a whole for funding allocation, and use a single agreement between the County and Good Samaritan rather than three separate agreements as executed in previous years. Staff will continue to monitor bed night data by shelter through reporting. The three shelters are the Santa Maria Emergency Shelter, Family Emergency Shelter (Santa Maria) and Bridgehouse Shelter (Lompoc). Staff recommends the Board approve the revised General Fund Shelter Operations Agreement for Good Samaritan Shelter in the amount of \$242,793, which is calculated based on 78,545 bed nights provided during the 2017-18 year. The remaining funding has been contracted to PATH, in the amount of \$102,206, and the Unitarian Society's Freedom Warming Centers, in the amount of \$50,000, under the parameters set by the Board.

Background:

General Fund contributions for the PATH Santa Barbara Emergency Shelter, Bridgehouse Emergency Shelter, Santa Maria Emergency Shelter, and Family Shelter have been allocated on a pro rata basis according to the number of emergency shelter beds reported during the preceding fiscal year. The Unitarian Society's Freedom Warming Centers also receive a General Fund contribution of \$50,000 each fiscal year. The table below shows the 2017-18 bed night data with percentage distribution resulting in the FY 2018-19 allocations for the four traditional emergency shelter locations (PATH Santa Barbara, Bridgehouse Emergency Shelter, Santa Maria Emergency Shelter, and Family Shelter) as well as the Freedom Warming Centers.

a. When invoicing the County, Good Samaritan Shelter will submit a Quarterly Status Report providing information on accomplishments including but not limited to beds provided, number of participants moved into housing at project exit, and data on race and ethnicity as well as homeless subpopulations. GSS will be reimbursed on a quarterly basis, and staff will continue to monitor reporting and expenditure documentation to ensure all reimbursements are fully supported.

Key Contract Risks:

The Shelter Operations General Fund Agreements are cost reimbursement contracts. The County will only reimburse shelter providers for costs that are eligible under the Agreements and documented in a manner that is acceptable to the County. CSD staff will assess the performance of those providers to determine if services are adequately provided. The County will provide payment after demonstration that reimbursable services were provided and performance goals were met.
